**Compensation Changes** 

- The new compensation structure reflects increased inflationary pressures on staff.
- It is intended to increase the UASU's competitiveness and provides greater flexibility in hiring negotiations while still maintaining a structured approach to compensation. This structured approach is a crucial foundation for ensuring equity in compensation; compensation is not tied to an individual manager's opinion.
- Due to restructuring, the new compensation structure will not significantly increase overall staff costs in the short term.
