

**THE STUDENTS' UNION, THE UNIVERSITY OF ALBERTA**  
**OFFICIAL RULES - The University of Alberta Student Vaccination Draw**

Published: 25 August 2021

**NO PURCHASE IS NECESSARY TO ENTER OR WIN.**

**1. Eligibility:** The University of Alberta Student Vaccination Draw (the "Contest") is open only to those who are University of Alberta undergraduate or graduate students during the Fall 2021 term, have received at minimum one shot of a vaccine for COVID-19 accepted by Health Canada, and who are sixteen (16) years of age or older as of the date of entry, who are residents of Canada who reside in any province or territory within Canada (excluding Quebec) and is void where prohibited by law. Employees of *The Students' Union, The University of Alberta* ("The Sponsor") their respective affiliates, subsidiaries (not including entities known as Student Groups), suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Contest. The Contest is subject to all applicable federal, provincial/territorial and local laws and regulations. Void where prohibited.

**2. Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of The Sponsor, as final and binding as it relates to the content. If you are under the age of majority in your province or territory of residence, you must have received the permission of a parent or guardian, who has agreed to be legally bound by these rules, (see Section 12 below) to enter the Contest and potentially become a winner of a prize. The Contest is subject to all applicable federal, provincial/territorial and local laws.

**3. Contest Period:** Entries will be accepted online starting on or about August 25, 2021 and ending September 10, 2021 2:59:59PM MST. All online entries must be received by September 10, 2021 2:59:59PM MST. Contest Sponsor reserve their right to cancel, terminate, modify, amend, extend or suspend the Contest, and select a winner from previously received applicable eligible Entries.

**4. How to Enter: No Purchase Necessary**

**Method One - Online Entry and Registration:** The Contest must be entered by using the method of entry stated on UASU Perks (<https://perks.uasu.ca>). The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or

specifications may be disqualified at the sole discretion of The Sponsor. You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, identities or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of The Sponsor.

**Method Two – Email Entry:** If a contestant does not wish to enter online, the contestant may: email his/her first name, last name, email address, telephone number, complete mailing address(including postal code) to the Sponsor, at: [contest@su.ualberta.ca](mailto:contest@su.ualberta.ca) with the subject line Email Entry- **University of Alberta Student Vaccination Draw**. Upon receipt and verification of a contestant's complete entry request in accordance with these Rules, the contestant will receive one entry into the Contest. To be eligible, all emailed entry requests must be received during the Contest Period.

**5. Prizes:** There is a total of ten (10) undergraduate tuition and some fees for one term prizes (the "Prize") available to be won, redeemable towards fees charged by the University of Alberta. The value of the tuition prize is equal to \$3046.50.

There are a total of two (2) graduate student tuition and some fees for one year prizes (the "Prize") available to be won, redeemable towards fees charged by the University of Alberta. The value of the tuition prize is equal to \$3758.00.

There is \$3192 in merchandise prizes ("Additional Prizing") available to be won by forty-one (41) entries. None of the merchandise prizing will consist of cash.

There are a total of six (6) experience prizes ("Experience Prizing") available to be won, consisting of breakfast with the University of Alberta President and a tour of the Dentistry-Pharmacy Building construction site. Approximate value of the prizing is \$16 per prize.

All amounts in these Rules are in Canadian dollars. The prize is non transferable. Any and all prize related expenses, including without limitation any and all federal, provincial/territorial and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by the winner is permitted. Acceptance of prize constitutes permission for The Sponsor to use winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

**6. Odds:** The odds of winning depend on the number of eligible entries received.

**7. Winner selection and notification:** The winner of the Contest will be selected in a random drawing under the supervision of the Sponsor on or about September 10, 2021 at 6:00:00PM MST. If the event

date is altered or postponed for any reason, the draw date may also be changed. In the event of a change the updated draw date will be posted at [www.uasu.ca](http://www.uasu.ca).

The winner will be notified via email following the winner selection. At the time of notification, the winner will have to submit verification of having received at minimum one shot of a vaccine for COVID-19 accepted by Health Canada. The winner must also submit verification of enrollment at the University of Alberta, and a summary of financial charges for the Fall 2021 term.

The Sponsor shall have no liability for the winner's failure to receive notices due to winners' spam, "other" inbox or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within forty-eight (48) hours from the time award notification was sent, does not correctly answer the mathematical skill testing question in the manner prescribed, is unable to provide acceptable proof of vaccination, unable to provide acceptable proof of enrollment at the University of Alberta, or fails to timely return a completed and executed declaration and releases as required, prize may be forfeited and/or an alternate winner selected at the discretion of the Sponsor.

The receipt by winner of the prize offered in this Contest is conditioned upon compliance with any and all federal and provincial/territorial laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER (AT SPONSOR'S SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF THE CONTEST AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

**8. Prize Delivery:** The Sponsor will work with the *University of Alberta, Office of the Registrar* to apply the prize directly to the winner's financial balance due for student tuition, through the student awards and scholarship system.

Additional Prizing will be available for pickup from the main offices of the Sponsor. The winners of additional prizing will be contacted with pickup details. Failure on the part of winners to pickup prizing is at the sole liability of the winners in question. Additional Prizing will only be available for pickup for a maximum of two (2) weeks.

Experience Prizing will be coordinated by the University of Alberta Office of the President. Failure to coordinate a time for use of the prize will be the sole liability of the winners in question.

**9. Rights Granted by you:** By entering this content you understand that the Students' Union, anyone acting on behalf of the Students' Union, or its respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and

throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Contest, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.

**10. Terms:** The Sponsor reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Contest should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Contest. In such case, The Sponsor may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by The Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions.

The Sponsor has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to; multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros or scripts or other technical means for entering.

Any attempt by an entrant to deliberately damage any web site or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws and should such an attempt be made, The Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.

**11. Limitation of Liability:** By entering you agree to release and hold harmless *The Students' Union, The University of Alberta*, its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) such entrant's participation in the Contest and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof, (ii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware or software; (iii) the unavailability or inaccessibility of any transmissions or telephone or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error which may occur in the administration of the Promotion or the processing of entries.

**12. Minors:** For greater certainty, where the selected contestant is under the age of majority in his/her province or territory of residence, as a pre-condition to the selected contestant being declared the winner

and receiving the prize, the parent or legal guardian of the selected contestant must consent in writing to the selected contestant being declared a winner and receiving a prize and must also sign and return to the Contest Sponsor the Contest Sponsor's form(s) of Declaration and Release documentation.

**13. Disputes:** THIS CONTEST IS GOVERNED BY THE LAWS OF CANADA, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in this Contest, participant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Contest, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Edmonton, Alberta having jurisdiction. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Contest), and participant further waives all rights to have damages multiplied or increased.
