- 2017-11/7a Bill #4 Removing Student Group Operating Policy Requirements *First reading*PACHES/CHRISTENSEN MOVE to approve the first reading of Bill #4 Removing Student Group Operating Policy Requirements, on the recommendation of Bylaw Committee, based on the following first principles.

 - 4. Bylaw 5600 shall be amended to remove operating policy requirements.

University Business

Provost and DoS

VP Scott and I will be meeting with Provost Steven Dew next week in our monthly meeting regarding academic affairs. VP Ushakov and I will be meeting with the Dean of Students soon for our monthly meeting as well. We continue to work closely with the Dean of Students on many files such as student group administration.

Academic Planning Committee (APC)

I attended an APC meeting where there were a number of items discussed. These include the future of the Peter Lougheed Leadership College, an update on deferred maintenance on campus, and an update on this year's financial aid given to students. I found the report on financial aid very interesting as administration provided data on financial aid trends.

External Business

CAUS Meeting

VP Larsen and I traveled down to Calgary for an in-person CAUS meeting. It was productive and we discussed our future advocacy on mental health funding, the CAUS 30th anniversary celebration, and received a presentation on transfer credits. Hello Council,

I hope the semester is going well – I know it's a busy time for many. It's also during busy times like this that I really appreciate the significant contributions students make to our campus community, be it through student groups, department or faculty associations, events on and off campus, and so much more – all on top of their academics and life more broadly. So a special thanks to all of you! Here are a few brief updates on what I have been actively doing since the last meeting:

Open Educational Resources Advocacy Group:

I have began attending a newly formed OER Advocacy group on campus. This group is in it's early stages but will be putting pressure on the campus community and the university to increase the creation, support and use of open educational resources on campus. OERs are a tried and tested way of lowering the costs of academic materials for students while maintaining the quality of student instruction.

Academic Relations Group:

The Academic Relations Group (ARG) had its' first meeting to discuss the role of ARG delegates, what their expectations are of each member, and what committees they want to attend. ARG delegate represent the Vice President Academic on a variety of boards and committees that the VPA is not able to attend; the selection of ARG delegates to represent the VP Academic should not be confused with the distinct nomination process of Students' Councils Nominating Committee.

University Vice President Research Committee

I have been busy over the last few months and especially over this week as I am a member of a search committee which has been tasked with hiring a new VP Research for the University. While I can't speak to specific candidates because the process is highly confidential, I can say that it is ongoing and an announcement will come in the fullness of time. The Vice President Research is in charge of building provincial, national, and international research collaborations, working with funding agencies, and industry, and supporting the scholarly community on campus.

Governance Update:

This is going to be a section that I will include on most reports moving forward, providing an update on some of the relevant content to undergraduate students that comes up at GFC and

its subcommittees.

Committee on the Learning Environment:

One major item discussed at this meeting was the "Faculty of Nursing Undergraduate Curriculum Renewal". This was presented by the Associate Dean of Undergraduate Programs in the Faculty of Nursing and was a comprehensive look at the plan and process for overhauling a large portion of the program. This includes new leadership courses, another practicum and a course on indigenous health in canada, among other changes. The new curriculum will be implemented in the 2018-2019 year.

Academic Standards Committee, Subcommittee on Standards:

ASC SOS is a committee which many items come for early consultation before being sent to the full Academic Standards Committee. At this meeting there was a number of issues discussed which primarily impacted Graduate Students. The most relevant item was from the Office of the Registrar, suggesting that the Canadian Academic English Language Computer Edition (CAEL CE) examination is permitted as a way to fulfill the english language proficiency requirement – the CAEL is already permitted and this is just a minor edit to allow for the online test that is being created.

General Faculties Council:

The next meeting of GFC will be on Monday October 30th at 2pm in Council Chambers. Items that will be discussed include the:

- Peter Lougheed Leadership College (PLLC) Next Steps
- Report of the GFC Committee on the Learning Environment (CLE) on Teaching and Learning and Teaching Evaluation and the Use of Universal Student Ratings of Instruction (USRI) as an Evaluation Tool
- Changes to the Admission of Aboriginal Students Calendar Section and updates to Faculty sections

I have also been busy meeting with Faculty Associations, department associations and a number of councillors. My office hours for the fall semester are Tuesdays from 12-1pm.

I look forward to hearing from you all.

Council,

Another October, another season of dropping temperatures and midterms! I hope that everyone had a good holiday weekend and was able to take some well-earned rest before midterms really swing into action. The last couple weeks have flown by, and I have some specific updates to share with you.

CREF Fund Renewal

I sat down with two members of the leadership team in Campus Community & Recreation, a department in the Faculty of Kinesiology, Sport, & Recreation on the topic of the upcoming plebiscite of the Campus Recreation Enhancement Fund (CREF). The CREF fund, a dedicated fee unit that assists the funding of club sports and other elements of athletics, is up for plebiscite this year. I walked the team through the process of plebiscite, and pointed them to our relevant bylaws. As part of my duty on Finance and Bylaw Committee, I will continue to be a resource for them leading up to relevant deadlines and the election period.

United Way Campaign Kick-Off

On October 11th the University of Alberta kicked off its United Way campaign! The campaign had a very successful kick-off event at noon on SUBstage featuring talks from President Turpin, Chancellor Stollery, Board Chair Phair, Sarah Chan and a champion of the United Way. It was well attend by university staff and students alike. Also, the SU will be donating 100% of the proceeds from coffee sales at The Daily Grind, Undergrind and L'Express from that day to the United Way UAlberta Campaign. If you bought a coffee that day, thank you, on behalf of the United Way. Together, I imagine the donation collected will be sizeable! We will know numbers sometime in the future.

MHT & Deferred Maintenance Consultations

Two of my platform points were to consult and create reports on two important topics at the university. I promised to consult relevant student groups on the Myer Horowitz Theatre Renovation Project and the issue of deferred maintenance on campus, and create reports on each. Specifically, I will be creating a report on student opinion of the Myer Horowitz Theatre Renovation Project and a report on student priorities in deferred maintenance. In



the past few weeks, with students settling into their schedule, I have began those consultations with sit down interviews. If you, or anyone you know, has thoughts on either of these topics please let me know. Also, do not hesitate to suggest groups that I should be consulting! Currently I will be consulting Faculty Associations, relevant Department Associations, the Greek community and relevant student groups.

Centre LRT Consultation

On October 10th I was involved in a consultation meeting for future LRT plans in the University of Alberta and Whyte Avenue area. The proposed line is called the "Centre Line". The current proposed route can be found on the City of Edmonton's website here. The consulting team and the city are currently creating a more specific route, and that is why they are bringing stakeholders in. Joining me at the meeting was the university architect, a senior staff member from Campus St. Jean, and the VP External of AUFSJ. We stressed convenience for students, student safety, walkability, bike accessibility on campus and the need for continuous consultation throughout the process. Please keep in mind that this consultation is very preliminary; do not expect to see finalized plans and construction for a few years.

UASU Investments

Also on October 10th, the Students' Union's Controller Peter Ta and I had one of our biannual meetings with our investment managers. Overall, our investments are doing well and meeting our return targets. For council's information, we hold a mixed investment portfolio of fixed assets and equity with the majority of our money being held in fixed assets. Into the next period, we are intending to diversify our investments to other markets of the world. Traditionally, we invested heavily in Canadian assets, but with the sluggish Canadian economy, we are looking elsewhere to ensure we are using our money effectively. Our investment managers made some excellent suggestions and we are working with them to optimize the return on our investments.

Bill #4 - Removing Student Group Operating Policy Requirements - Second reading

PACHES/CHRISTENSEN MOVE to approve the first reading of Bill #4 - Removing Student Group Operating Policy Requirements, on the recommendation of Bylaw Committee, based on the following first principles.

- 1. Bylaw 5600 currently requires that SU operating policy have "the following categories for student groups: registration requirements, privileges and services, administrative framework, constitutional reviews of student groups, grounds for suspension and termination, and granting."

- 3. Operating policy is generally considered an internal Students' Union document for the organization itself, specifically employee training, rather than to be applied to external student groups.
- 4. Bylaw 5600 shall be amended to remove operating policy requirements.







(September - August)






TOTAL DENTAL CLAIMS


Total Dental Claims







BIOLOGICS INFORMATION

A biopharmaceutical, also known as a biologic medical product or more simply as a biologic or biological, is any medicinal product manufactured in or extracted from biological sources. Biopharmaceuticals are distinct from chemically synthesized pharmaceutical products. Examples of biopharmaceuticals include vaccines, blood or blood components, allergenics, somatic cells, gene therapies, tissues, recombinant therapeutic protein, and living cells. However, in most cases, the term "biologics" is used more restrictively for a class of therapeutics (either approved or in development) that are produced by means of biological processes involving recombinant DNA technology.

Office Hours

Councillor Jones October 17th, 2017

Overview:

It's in my opinion that councillors need to be engaging with their constituents more and a possible avenue for this is would be office hours. The concept of office hours isn't new and is already implemented by groups like ISSS (The interdepartmental science student society) for their directors and councillors. Initially I brought this idea forward in CAC. Since then I have spoken with many constituents and brought the idea back to CAC. There seemed to be interest in the idea so i'm sharing what I found with Council. This isn't something mandatory, but an idea I wanted to promote.

Considerations when choosing a location:

Comfort

A recurring theme I heard from people is that this needs to a place that is comfy. For some people this meant a place that wasn't noisy, for some people they didn't want a stuff stoic room. For some it was a matter of where they physically were sitting with couches being a popular choice. What came up most often was the notion that that office hours should be in a more public open place as opposed to a well hidden office.

Accessability

Another consideration I from talking to people is that accessibility needs to be a concern. Some people don't do well with noise, and mobility concerns were also brought up, whether in regards to the types of chairs one sits in, wheelchair accessibility and more. We live in a very ableist society so this must always be kept in mind.

Faculty specific considerations

In hindsight, I realize that a lot of the students I talked to were science students, in addition to a few arts students, so the information I gathered may be bias. One consideration is the fact that any optimal location for office hours may be different for everyone depending on their faculty. Not everyone goes to SUB. For example, a lot of science constituents I talked to suggested places in CCIS. I do believe this is a very specific because of their faculty.

Recently I talked with Crystal Liu , the president of ISSS (who informally brought this idea to ISSS council) and they're interested in talking about the possibility of having individual science councillors additionally being in the office during ISSS office hours with the caveat that everyone meets first ahead of time. Unfortunately I can't speak for every faculty association.

Current considerations for the Students' Council room

Upon further consultation I don't think the Students' Council room is a good choice for office hours. Sometimes it is cold, it's very stoic, doesn't' feel approachable and thus in it's current state, doesn't seem like a good idea. However, I think this office could still be utilized for more private 1 on 1's. For instance if someone doesn't feel comfortable speaking about something in a more public setting or gets anxious in crowds.

Moving forward

- 1. The Council Room should be more welcoming
 - a. This is more CAC business, but suggestions on how to make the office more approachable would be appreciated!
- 2. Office hour recommendations
 - a. Take accessibility in mind. This includes how approachable the location, how noisy it is, whether it's accessible to people of different mobility etc. More points can and should be elaborated on.
 - b. If possible, work with your Faculty Association. I believe this could really foster SU- FA (Faculty Association) relations as currently not every councillor is involved with their FA or even knows what their FA does. This is my personal suggestion but at the end of the day not every FA will be on board with this. Faculty specific locations or basement SUB are other great options.
 - c. An option i'm personally interested in exploring is working with ASC (Aboriginal Students' Council) and seeing if they would be interested in working together. I have yet to talk to them so far.
 - d. A suggestion I heard was that a sign would help identify councillors when they are holding office hours in public.
 - e. This opportunity would be a great purpose and occasion for councillor jackets.
