I. Parent Orientation (August 18 and September 1)

On August 18 and September 1, I had the opportunity run a session in Parent Orientation. This session was entitled "Academics at the U of A" and was co-presented with Dr. Margaret Ann-Armour. I found this to be a great chance to meet parents of first-year students and answer their questions/address their concerns regarding the academic environment at the University of Alberta from both a student and professor perspective. Kudos to the Orientation staff for putting on such an excellent event – I certainly enjoyed my opportunity to participate and I know that the parents did as well.

II. University of Alberta/Economic Development Edmonton Federal Liberal Caucus Breakfast (August 23)
