## Proposal to Develop a Multi-Year Tuition Policy

At present, the development of tuition policy by the Students' Union is an event that occurs at least annually, and sometimes more frequently. The 2003-2004 year, for example, was a veritable orgy of tuition-policy-changing activity, with the average lifespan for any one policy being less than a month. The shortest-lived policy, calling for "no tuition increase within the next twenty minutes," was adopted and summarily replaced over the course of a single meeting. Indeed, such was Council's enthusiasm for amending tuition policies that it once (upon the considered recommendation of the Tuition Undertakings, Planning, and Action Committee) adopted the General Motors Canada 1998-1999 Audited Financial Statements as the organization's tuition policy (which former President Mike Hudema immediately criticized as "not hard-line enough").

Since taking office, University Vice President (Academic) and Provost Dr. Carl Amrhein has opposed this state of affairs, noting that dealings with the S.U. have been somewhat difficult since its tuition policy would often change in the middle of one of President Mat Brechtel's sentences. At Amrhein's request, Council authorized Brechtel to enter into negotiations aimed at making a reality out of a revolutionary concept: a Students' Union tuition policy designed to last more than one year.

At the heart of the proposal is an agreement by the Students' Union to establish a tuition policy to last for the entire 2004-2005 and 2005-2006 years, with the policy in question calling for "whatever tuition rate is deemed advisable by the University of Alberta administration." In exchange for this policy, Amrhein has offered a number of significant concessions, including:

- 1. an agreement by the University to not seek any tuition increase beyond the provincially-allowable maximum during the life of the agreement;
- 2. an agreement by the University that a portion of any "leprechaun-related revenues" brought in by the University be applied directly against tuition increases, with the portion to be determined on a sliding scale ranging from 0% of the first \$100 billion to 0.3% of any amount above one gazillion dollars;
- 3. a non-voting, non-speaking, and non-attending seat for the Students' Union President on the University's Art Acquisition Committee;
- 4. the right of the Students' Union to contribute money to any provincially-targeted University campaign; and
- 5. one (1) Acme Sunshine Blower 2000<sup>TM</sup> (rectal variety), such that the Students' Union can have sunshine blown up its collective ass even in Amrhein's absence.

It is the considered recommendation of the Magic Committee of Hilariously Adept and Memorable Maniacs Eschewing Recommendations (MCHAMMER) that this proposal be accepted unread.
