University Policy Committee

Thursday July 20, 2006

The University Policy Committee met for the fifth time on July 20, 2006. All members, except for Councillor Sumar were in attendance as well as guest Chris Henderson, Students' Union University Affairs Officer.

The presentation, being the primary item of business and most time-consuming, was postponed to the end of the meeting. This allowed for quicker items to be dealt with in a timely manner.

In Executive Officer reports, Vice President Henry notified the Committee that she had submitted changes to the Add/Drop Deadline political policy to Council and not UPC, and she pledged to bring discussion items from recent meetings with WebCT. Vice President Yusuf had nothing to add to his written report.

Question Period was minimized due to time restraints, and Old Business was tabled to the next meeting to allow more time for the presentation.

New Business was the Political Policy for International Student Engineering Co-Op Accessibility. After a brief discussion, it was decided that the principles moved by Eruvbetine and passed by Council should be forwarded to the Executive (in accordance with Council Standing Orders). The Committee also decided that there needs to be a discussion in the future about how to streamline the policy process so that UPC doesn't have to have 2 meetings to refer and then discuss a political policy between readings.

In Discussion Items, Committee Strategic Planning and Teaching & Research Political Policies were tabled to the next meeting. The Chair notified the Committee that Councillor Sumar had exhausted all avenues for finding a proxy, and he will be requested to contribute outside of meetings. The UPC web site has yet to be updated due to technical difficulties, despite the best efforts of the Administrative Assistant—Students' Council. The Chair will be working with her to make it more functional and better organized as soon as possible. They will also try to find the archived Student Life Board minutes, as they seem to have been misplaced when the University Policy Committee and Student Affairs Committee merged.

The climax of the meeting was the presentation given by Chris Henderson on University Governance and Affairs, which served to enlighten all those present and better equip the Committee to undertake strategic planning on policy issues. Henderson will be distributing a copy of his presentation slides and notes to the Committee members.

The meeting was adjourned at 8:25 pm. The next meeting of the University Policy Committee will take place at 6:00 pm on Thursday, August 3, 2006.

1.) Presentation from CAUS Executive Director, Duncan Wojtaszek

Samuel: Now for Duncan's part of the program – take us where you feel you need to.

Wojtaszek: Thanks – this presentation is basically the one that I was planning on giving Council, so I'm going to alter it by trying to give you more chances to interrupt.

Highlights/Synopsis of presentation

Political Culture of Alberta

- -Alberta has a political culture of a populist province (common sense should prevail)
- -Also, the impression is that monolithic province, and an outsider from Canada

- -Alberta was created because Wilfred Laurier believed it would elect Liberals
- -Tradition of a one-party government (less plurality and diversity of political opinion)

How this affects Post-Secondary Education

- -Populism breeds the opinion that Universities should serve the community they should be beholden to the population
- -Distrust of academia and academics (not just government the general population)
- -Especially predominant in older generations
- -There is a desire to have "Made-in-Alberta" solutions (innovation)
- -In Ontario University presidents put an ad in the paper that decried the province for under-funding, and demanded change this WOULD never happen in Alberta

1992 and beyond

- -Feeling that Alberta was mismanaging finances perception of overspending
- -Massive cuts haven't been recouped in Post-Secondary Education
- -Deferred maintenance costs like fixing ceilings, painting rooms, etc. eventually have to get done!
- -PŠE deferred maintenance bill currently exceeds \$1 billion
- -University also decreased faculty pay and hired more sessional instructors
- -Impacts of quality of education
- -Increase in tuition (about 300% increase since that time well past inflation)
- -Tremendous increase in demand and enrollment
- -Increases in areas of demand particularly females

[Break for pizza. We discuss Superman. And comic books. Who says Student Councilors are nerds?

Also – Tim Schneider likes boobies. So does Bill Clinton. Look, you had to be there.]

-A lot of the increase was borne by colleges – led to increased flexibility in PSE (eg. First two-years at colleges, and finish two years at a University)

How does it affect us now?

- -Colleges can now grant degrees largely due to increase in demand
- -This is not unique to Alberta happening across Canada
- -Huge increase on student loan program a much higher number of loans go out (around 50% get them, and average debt load is \$20k)
- -Universities now see students as a source of income
- -Degrees now seen in terms of "product" and "consumer"
- -Budget size is now seen as a measure of prestige
- -Is budget size a fair measure? That's debatable [and we debated it]
- -No University pursues a purely undergraduate agenda U of C and U of A have pursued increased research programs aggressively

Modern Day

- -2004 election the Progressive Conservative Party lost votes "to the right" (Alberta Alliance and votes not cast), meaning that they are now talking about change by moving farther to the right
- -Premier is now leaving, if you haven't heard
- -Now there is a vacuum of government vision the previous mandate of restoring fiscal responsibility has been eclipsed
- -We now have enormous resource revenues and a booming economy
- -Huge demand for labor now a lot coming from the oil sands
- -We've seen a (relative) increase in PSE investment over the last two years

- -Higher increase in base operating grants (4% vs. 6%)
- -Since then, they've also introduced "A Learning Alberta"

[Dave hands out a leaflet, describing "The Devolution of Alberta's Tuition Policy."

Samuel: There's a lot of numbers here!

Wojtaszek: You can't get around that when you're talking about tuition. The arguments are always going to be based around numbers.]

[Duncan now talks about his handout with a timeline from 2000-2007.]

Wojtaszek: I want to emphasize that a lot of the positive strides we have made are due to the focus on campaigning to the public as opposed to the students.

. . .

As a student movement, we've departed from a strictly government relations standpoint to a more public-orientated position. We are spending much more on provincial lobbying now then we used to be. We might spend less money lobbying the federal government, but the U of A Students' Union is the lead flagship institution for the student movement in this province, but we haven't been doing it in isolation – everyone has been spending progressively more on advocacy. Are we getting value for that money? Well, last year, we saved \$87 million in tuition – I would say we're doing fine for return on investment. We're criticized that we spend too much time talking about tuition – but someone should be talking about it, and we've been the only group talking about it up until now.

[Discussion around effectiveness of the student movement. We're pretty awesome, as it turns out.]

[We also talk about colleges being able to grant degrees in the province. It's a pretty awesome conversation – and I'm not going to minute it, because it will hurt feelings.]

[At some point, the conversation devolves into us talking academic philosophy and other assorted external good times. We eventually blend into an adjournment.]

Specific:

- Topic: Affordable Universal Transit Pass

WHEREAS a clear majority of Students' Union members voted in March of 2004 to support a Universal Transit Pass through a campus-wide referendum;

WHEREAS a Universal Transit Pass will present undergraduate students with significantly more affordable access to public transit;

WHEREAS the Universal Transit Pass will improve the student experience and better serve students' needs;

WHEREAS Universities and Students' Unions across Canada and the United States have successfully implemented affordable Universal Transit Pass programs;

WHEREAS in addition to the tangible improvements for access and affordability, a Universal Transit Pass can help reduce reliance on automobiles and thus reduce greenhouse gases and free up campus parking areas for academic or green purposes.

BE IT RESOLVED that the University of Alberta Students' Union negotiate with the regional municipalities, transit services, and the University of Alberta to establish the terms of an affordable Universal Transit Pass for Students' Union members subject the following conditions:

- a) the municipalities must cover all capital costs associated with the program;
- b) the cost of additional transit service to accommodate new transit users be subsidized by the normal amount of other municipal transit services;
- c) a fair annual cost-escalator provision will be created;
- d) the municipalities and the University will contribute financially to the project on an ongoing basis commensurate with benefits to the wider and campus communities, and the transit system;
- e) that the final cost brought forward in a Students' Union referendum be the direct cost per-student, plus optionally an inflation indexed amount per-term to cover a subsidy program and administrative costs, if necessary.
