2015-22/6a Councillor Christensen to Vice President Bondarchuk: Earlier in the term there was discussion surrounding the future renovation/modernization of the Myer Horowitz theatre and I was wondering if you could please provide Students' Council with a written update/refresher on what the current status is, if there are any plans for moving forward and when council might expect to hear more about updating this quite important service/venue offered by the Students' Union?

2015-22/6b Vice President Bondarchuk's response to Councillor Christensen:

Since I last updated Council, the theatre consultants we hired have been engaged in completing a detailed assessment of the space, and will lay out options for the renovation of the theatre. The report we receive from them (expected next week) will be used by the 2016-17 Executive Committee to determine our priorities and decide on a course of action for the project.

We are exploring several options for upgrades which range from \$3 to \$8 million in cost, and the project may be completed in different phases. Unfortunately, I don't have any more information beyond this, as it will be up to next year's team to analyze the report and make decisions on moving forward and planning fundraising. I can say that the project will be moving forward in some form, and I think I can safely assume some minor work will be done this summer.

1) The Students' Union holds a number of financial reserves for the purpose of large-expense projects not outlined in an annual budget.

2) The Elections Reserve is distinct from the other reserves in that it may be used more frequently and unexpectedly than other reserves.

3) The Elections Reserve shall be renamed to the Campaign and Advocacy Reserve, and the definition shall be changed to include advocacy campaigns towards the University, for clarity.

4) Guidelines shall be set for use of the reserve, where the Executive Committee has authority to approve up to \$5,000 in spending for a single campaign before requiring Finance Committee to release additional funds.

5) An upper limit shall be set on the accrual of the reserve, where additional funds outside the limit will be reallocated to the operating budget on an annual basis.

Budget Principles 2016-17

This is intended to serve as an outline of the fiscal priorities of the University of Alberta Students' Union for the fiscal year beginning May 1, 2016 and ending April 30, 2017. This document is legislated under Students' Council Standing Orders, and is mandated as a responsibility of the Vice-President (Operations and Finance) under Bylaw 1100.

<u>Preamble</u>

The Students' Union is guided by our Strategic Plan. Our mission is to serve, represent, and engage students. The four pillars that support our mission are:

Fiscal Considerations

Budget principles shall outline the basic direction for creation of the budget. The following adjustments lie outside of budget principles and, while they should be considered in the submission, are at the sole discretion of Students' Council and/or any other legislative body outlined in Bylaw:

- Alberta Consumer Price Index (ACPI) calculations for 2016-17
- Total membership revenue based on enrolment estimates from the Office of the Registrar
- Changes to the Post-Secondary Learning Act by the Government of Alberta
- Students' Union Membership Fee increases (beyond inflation) and decreases
- Students' Union Dedicated Fee increases (beyond inflation), decreases, creation, and/or elimination



<u>Principles</u>

- 1. In the event that a section of this document conflicts with any other section, the Finance Committee shall identify such a conflict and propose any necessary changes in the presentation of the final budget.
- 2. Total operating and capital expenditures will not exceed the amount of total operating and fee revenues. The only exception to this would be council-approved capital purchases that do not cause a deficit on an accrual basis.
- 3. Capital budgeting shall be apportioned at the discretion of the Financial Controller and Vice President (Operations and Finance) after the operating budget has been created. Using the set amount of capital funds allocated, decisions for use of capital funds shall be made by the Core Manager responsible for each unit. (**new**)
- 4. The Students' Union shall not budget for a deficit in its operating and capital budget. Growth in a department shall be offset by a variety of strengthened revenue streams in that department, where possible.
- 5. All departments must work within the mandate of the Students' Union; activities or operations deemed to be beyond its scope shall be eliminated. The 2015-2018 Strategic Plan shall be used as a guide to assess relevance and value prior to such decisions.
- 6. External entities such as dedicated fee units and operating grants shall be managed as per existing Students' Union Bylaws and applicable contracts.
- 7. Unless otherwise noted, operating and fixed costs increase at a rate relative to the previous fiscal year no higher than inflation for the province of Alberta; activity of the Students' Union will continue in a manner consistent with the precedent set in previous fiscal years.
- 8. The Students' Union shall implement all necessary financial restraints and audits as required by the Post Secondary Learning Act and its own Bylaws and Standing Orders.
- 9. Staff costs shall change as specified in the CUPE (Canadian Union of Public Employees) collective agreement. Managerial and other union-exempt staff who are not term staff are entitled to a merit increase in accordance with their respective employment agreements and appraisal outcomes. (**new**)
- 10. Operating and dedicated fees shall increase in accordance with the Students' Union Bylaw 3000, as set out in the 1992 referendum approving increases based on the Alberta Consumer Price Index. Based on estimates, ACPI for 2016-17 will be approximately 1.29%.
- 11. In addition to ACPI increases, the Students' Union's Membership Fee shall increase by no more than an additional 10%, subject to approval by Students' Council, in direct response to the Alberta government's long-term plan to increase minimum wage. (new)

- 12. Resources shall be made available for recurring projects of the Executive Committee, provided they can show need for such resources and consistency of such projects. (**new**)
- 13. Resources shall be made available to promote and enhance visibility and constituency engagement for members of Students' Council. (**new**)
- 14. The Students' Union shall allocate resources to provide sufficient staffing to support student governance objectives.
- 15. The Students' Union shall allocate resources toward professional advice and services as they relate to advocacy.
- 16. Resources shall be made available for increased administration of student groups, should the Students' Union need to increase capacity in Student Group Services. (**new**)
- 17. The Students' Union business units shall not budget for a deficit prior to cost apportionment allocations. All reasonable attempts to maximize the profitability of these business units, consistent with the mandate of the Students' Union as a service provider, shall be made.
- 18. In line with Operating Policy 5.12, non-academic materials offered for sale shall have price increases approved by the Core Manager responsible for that unit when necessary to balance annual expected revenue with expected costs. Where costs have increased in academic material areas, there shall be a marginal increase to compensate. (**new**)
- 19. New lease space shall be available in the Students' Union Building and may need to be funded accordingly.
- 20. The Students' Union shall allocate resources toward customer experience improvements in its licenced establishments.
- 21. The Students' Union shall allocate additional resources toward front-facing visual and operational improvements for its businesses and venues. (**new**)
- 22. Steps shall be taken towards the creation of a client services program for the purpose of creating efficiency and value for the booking of conferences and other multi-step events in the Students' Union Building. (**new**)
- 23. Where possible, all entertainment units shall plan to recover all costs. Admission sales, sponsorship, and donations are acceptable sources of revenue.
- 24. Resources shall be allocated towards improving the audio and visual components of the Students' Union's venues. (**new**)

INIVERSITY OF ALBERTA

- 25. The Students' Union shall make resources available towards a renovation to the Myer Horowitz Theatre. (**new**)
- 26. Costs associated with Marketing and Communications, Facilities and Operations, and Administration shall be apportioned to all departments of the Students' Union based on usage.

Removed Principles (2015-16)

- 1. When possible, precedence in capital budgeting shall be given to expenditures contemplated in the 5-Year Capital Plan.
- 2. Capital expenditures shall be incurred based upon the following criteria: (a) replacement due to wear and tear; (b) to ensure continued operations of a particular unit; (c) to enhance the security or functionality of a particular unit; and/or (d) to strengthen the viability of a particular unit.
- 3. The services units of the Students' Union shall undergo a staffing restructuring.
- 4. The services total budget will be within 5% of last year's budget.
- 5. An average margin increase to non-academic materials not resulting from decreasing costs shall not exceed 10%.
- 6. For the purpose of the budget principles discussion, programming that takes place in a Students' Union venue or event that is not specifically mentioned in the above list shall be considered as separate from the entertainment and programming units.
- 7. The Students' Union shall allocate additional resources toward the Students' Union Building Renovation project.
- 8. The Students' Union will investigate the expansion of the administrative offices and may allocate funding to the initiative.
- 9. Ombuds is removed as a service of the Students' Union.

A Bylaw Respecting Students' Union Finances

1 Fiscal Year

1. The fiscal year of the Students' Union lasts from May 1 until the following April 30.

2 Audit

- 1. The Students' Union's financial statements shall be audited annually by a qualified accountant.
- 2. Students' Council shall approve each fiscal year's audited financial statements before the conclusion of the ensuing fiscal year.

3 Reserves

- 1. Students' Union reserves are
 - a. the General Operations Reserve,
 - b. the Capital Equipment Reserve,
 - c. the Building Reserve,
 - d. the Sponsorship Reserve,
 - e. the Campaign and Advocacy Reserve,
 - f. the Student Involvement Endowment Fund, and
 - g. the Access Fund.
 - h. each individual Dedicated Fee Unit listed in the Bylaw 6100 schedule
- 2. The General Operations Reserve shall be used for the operations of the Students' Union as provided for in the operating budget.
- 3. The Capital Equipment Reserve shall be used for the purchase and replacement of Students' Union capital equipment.
- 4. The Building Reserve shall be used for the enhancement of facilities controlled by the Students' Union.
- 5. The Sponsorship Reserve shall be used for the support of such Students' Union activities as may be identified in the operating budget as requiring sponsorship support.
- 6. The Campaign and Advocacy Reserve shall be used to support Students' Union endorsed advocacy campaigns related to municipal, provincial, and federal governments, as well as advocacy campaigns directed towards the University of Alberta administration or a department of the University.
 - a. The Campaign and Advocacy Reserve shall not exceed \$60,000 at any time.
 - b. The Executive Committee may approve up to \$5,000 in spending from the Campaign and Advocacy Reserve on a single campaign. Any spending above \$5,000 for a single campaign shall be approved by Finance Committee.
- 7. The Student Involvement Endowment Fund shall be used for the support of the awards provided by the Awards Committee.
- 8. The Access Fund shall be used for the support of undergraduate University of Alberta students requiring financial assistance.
- 9. Except as otherwise provided in Students' Union bylaw, Students' Council retains the sole authority to transfer or spend money in a Students' Union reserve.
- 10. A budgeted reserve not spent in its entirety, shall have its budgeted monies available in future year(s) for related purchases as originally deemed. Reserve funds carried over shall be accurately and openly presented on the audited financial statements.

4 Form of Operating Budget

- 1. The Students' Union's operating budget shall take the form of the level of revenue and expenditure for each Students' Union operational unit.
- 2. The Students' Union operating budget shall include an allocation of not more than fifty thousand dollars per year, designated the Projects Allocation, to be used for projects that may arise over the course of the fiscal year.
- 3. The Students' Union's operating budget shall include an allocation of thirty thousand dollars per year,

designated the Contingency Allocation, to be used for vital and unforeseen expenditures that may arise over the course of the fiscal year.

4. Except as otherwise provided for by Students' Union legislation, no person has the authority to make any expenditure of Students' Union funds or to seek actively to raise any revenue not contemplated in the operating budget.

5 Allocation Spending Authority

- 1. Students' Council has the authority to approve expenditures from the Projects Allocation.
- The Executive Committee has the authority to approve expenditures from the Projects Allocation of not more than five thousand dollars for any single purpose.
- 3. The Executive Committee has the exclusive authority to approve expenditures from the Contingency Allocation.

6 Budget Process

- 1. Students' Council shall approve an operating budget before the beginning of each fiscal year.
- 2. In the event that Students' Council does not approve an operating budget before the beginning of a fiscal year, that fiscal year's operating budget shall be identical to the previous year's operating budget until Students' Council does approve an operating budget.
- 3. Students' Council shall approve a set of budget principles dictating the priorities to be enshrined in the operating budget prior to the approval of each operating budget.
- 4. A budget process shall be set out in standing orders of Students' Council.

7 Fees

- 1. The Students' Union's operating budget shall include the level of the base Students' Union membership fee.
- 2. The base Students' Union membership fee shall not fluctuate by more than fifteen percent from year to year
- 3. In addition to the base Students' Union membership fee, Chair of Finance Committee shall maintain a schedule of dedicated fees to be collected.
- 4. The fees on the schedule shall be divided into Class A Fees, and Class B Fees.
- 5. Class A Fees may be amended or abolished only by
 - a. Students' Council, or
 - b. referendum.
- 6. Class B fees may be amended or abolished as outlined in Bylaw 6100.
- 7. Unless otherwise specified in the schedule, all fees in the schedule increase annually at a rate equal to the Consumer Price Index for the province of Alberta.
- 8. Each Class A Fee, and Class B Fee listed on the schedule shall be allocated to a reserve specified in the schedule.
- 9. the schedule shall stipulate whether each fee is payable by students enrolled at Augustana Faculty
- 10. The Students' Union will not allow for the implementation of a dedicated fee unit that, or
 - a. would cause the Students' Union to breach its fiduciary responsibility to the Students' Union; or
 b. supports activities that are beyond the scope and mandate of the Students' Union as outlined in the Post Secondary Learning act §93(3)
- 11. For the purpose of determining the scope and mandate of the Students' Union, Students' Council will consider whether the activities that are in question would:
 - a. provide services that are of a direct benefit to the University of Alberta campus community, including students in their pursuit of a post secondary education; or
 - b. eliminate obstacles for students in their pursuit of a post secondary education at the University of Alberta

1. Except as otherwise noted in Student Union bylaw, the Executive Committee has the exclusive authority to approve loans of Students' Union funds.

9 Contracts

1. A contract shall require the approval of Students' Council where

a. the term of the contract exceeds one year;

- b. there are no means by which the Students' Union may cancel the contract on six months notice or less; and
- c. the contract requires of the Students' Union a financial commitment exceeding five thousand dollars in any one year or twenty-five thousand dollars in aggregate.

10 Signing Authority

- 1. All cheques and contracts must be signed by at least one of the Vice President (Operations & Finance) or the President.
 - a. The Vice President (Operations & Finance) or President may delegate this authority to a member of the Executive Committee or Senior Management of the Students' Union if:
 - i. Both the Vice President (Operations & Finance) and the President are simultaneously unavailable and time is of the essence; or
 - ii. It is practical to do so.

A Bylaw Respecting Dedicated Fee Units

1 Amendments

1. Any amendments to this Bylaw must be reported to each Dedicated Fee Unit.

2 Definitions

- 1. "Dedicated Fee Unit" shall refer to any entity that collects fees from students through the Students' Union for the purposes of covering operating costs or providing grants under this bylaw.
- 2. "Registered Student Group" shall refer to a student group at the University of Alberta that has successfully registered with Student Group Services.

3. "Finance Committee" shall refer to the University of Alberta Students' Council Finance Committee.

- 4. "Referendum" shall refer to the definition in Bylaw 2200
- 5. "CPI" shall refer to the Consumer Price Index for the Province of Alberta

3 Creation

- 1. Dedicated Fee Units shall only be created after a successful Referendum.
- 2. Entities that wish to establish a Dedicated Fee Unit shall submit a proposal to the main office of the Students' Union by November 15th, of the year before the fee is to be implemented.
- 3. The proposal must outline at minimum:
 - a. The purpose of the fee;
 - b. The amount, per student per term, of the fee;
 - c. Whether students are able to opt out of the fee;
 - d. How the fee is administered to part time students and Augustana;
 - e. Whether or not the fee applies to the Spring and Summer terms;
 - f. Any other requirements specific to the type of fee being proposed.
- 4. Upon receipt, the proposal shall be immediately forwarded to the Bylaw Committee.
- 5. The Bylaw Committee shall approve within fourteen (14) days from receiving the proposal, a petition question
 - that reflects the original intent of the proposal and outlines the following:
 - a. The purpose of the fee;
 - b. The amount, per student per term, of the fee;
 - c. The composition of the committee or board overseeing administration of the fee;
 - d. A provision for the appointment of minimum one Students' Council member by Students' Council to the board or committee overseeing administration of the fee, as a voting member;
 - e. How the fee is administered to part time, Augustana, and off campus students;
 - f. Whether or not the fee applies to the Spring and Summer terms;
 - g. If any portion of the fee is for a University facility or service, a provision to guarantee access by any Students' Union member to that facility or service; and
 - h. If students may opt out of paying the fee, a provision for them to do so online, provided by the Students' Union
- 6. If the Bylaw Committee is perceived to have failed in this matter, the issue may be brought to the Disciplinary Interpretation and Enforcement Board by the entity proposing the question.
- 7. Students' Council will not allow for the implementation of a Dedicated Fee Unit that:
 - a. would cause the Students' Council to breach its fiduciary responsibility to the Students' Union; or
 b. supports activities that are beyond the scope and mandate of the Students' Union as outlined in the Post Secondary Learning Act.
- 8. For the purposes of determining the scope and mandate of the Students' Union, Students' Council will consider whether the activities that are in questions would
 - a. provide services that directly benefit the University of Alberta campus community, including students in their pursuit of a post secondary education; or
 - b. eliminate obstacles for students in their pursuit of a post secondary education at the University of Alberta.
- 9. The entity wishing to establish a fee must return a signed, valid petition to the Chief Returning Officer of the SU as per Bylaw 2200 in order to initiate a Referendum.
- 10. Students' Union services or operations may request that Council consider their proposed question for a Referendum on a Dedicated Fee Unit without conducting the petition subject to the following conditions: a. the question has been drafted by Bylaw Committee;
 - b. the question satisfies all conditions outlined under section 3.5 of this bylaw; and
 - c. if the referendum is successful, the service or operation ceases to be provided by the Students' Union
- 11. Except as otherwise stipulated in this bylaw, any Referendum shall be conducted in accordance with Bylaw 2200.

4 Review

- 1. Dedicated Fee Units shall be re-evaluated by plebiscite at least every five (5) years.
- 2. The plebiscite question shall be drafted in the same manner as the original petition question, as outlined in Section 3.5 of this bylaw
- 3. If a Dedicated Fee Unit fails to submit the proposed question by November 1, Bylaw committee will assume responsibility for drafting the plebiscite question.
- 4. Bylaw Committee shall submit an approved plebiscite question to Students' Council for ratification by December 1.
- 5. Upon ratification by Students' Council, the chair of Bylaw Committee shall notify the Chief Returning Officer of the approved plebiscite question.
 - a. A representative from the board of the Dedicated Fee Unit as outlined in the Bylaw 6000 Schedule shall be required to fulfill the role of side manager for the yes side of the plebiscite.
 - b. The Chief Returning Officer shall put out a call for the side manager of the no side of the plebiscite in accordance with Bylaw 2200.
- 6. Dedicated Fee Units may be amended or abolished only by:
 - a. a joint resolution of Students' Council and one other body, specified in the schedule; or b. Referendum.
- 7. Dedicated Fee Units that wish to raise their fee beyond CPI must first hold a Referendum as per Section 3 of this bylaw.

5 Oversight

- 1. Finance Committee shall be responsible for the oversight of all Dedicated Fee Units.
- 2. Finance Committee may make requests for financial documentation from Dedicated Fee Units as deemed necessary.
- 3. A Schedule detailing the following information for each Dedicated Fee Unit shall be maintained by the Vice President Operations and Finance:
 - a. a description of the fee;
 - b. the amount of the fee;
 - c. whether the fee increases and by how much;
 - d. whether the fee is opt out;
 - e. the next scheduled plebiscite date; and
 - f. whether part time, off campus, and Augustana students are required to pay the fee
- 4. Unless otherwise specified in the appropriate Schedule, all fees in the Schedules increase annually at a rate equal to CPI.
- 5. For all fees with an opt-out mechanism, the Students' Union shall exclusively provide for online opt-outs.

6 Conditions of Receipt

- 1. In order for a Dedicated Fee Unit to receive funds from the Students' Union, it must:
 - a. fulfill all reporting requirements; and
 - b. be fulfilling all relevant mandates, bylaws, and standing orders.
- 2. No funds shall be disbursed to a Dedicated Fee Unit until such time as the Finance Committee has approved this disbursal.
- 3. Where a Dedicated Fee Unit is in compliance with the conditions set out in 6.1, the Finance Committee shall approve the disbursal of funds by August 31 of that fiscal year or within four weeks, whichever is later.
- 4. Finance Committee may postpone its disbursement decision if:
 - a. there are any new inconsistencies or breaches from past years with the documents required during the relevant time period; and
 - b. those new inconsistencies or breaches have not been rectified.

A Bylaw Respecting Students' Union Bilingualism

1 Translation Requirements

- 1. The following governing documents of the Students' Union shall be made publicly available in both English and French:
 - a. Bylaw; and
 - b. Political Policy.

2 Process

1. The process for translating governing documents of the Students' Union shall be outlined in Operating Policy.

3 Timeline

- 1. The following governing documents of the Students' Union shall be reviewed annually for changes passed by Students' Council:
 - a. Bylaw; and
 - b. Political Policy.
- 2. Council Administration Committee shall be responsible for ensuring the translation process outlined in Operating Policy occurs in a timely manner.

4 Enforceability

- 1. Students' Council shall debate the English version of first and second readings of Bylaw and Political Policy.
- The English version of governing documents shall be enforceable.
 When discrepancies arise between the two translations, the English version shall take precedence.

5 Delay of Implementation

- 1. Implementation of this Bylaw shall be delayed until the following is accomplished:
 - a. a sustainable method of translation is established; and
 - b. an initial translation of Bylaw and Political Policy is performed.
- 2. The sustainable method of translation shall be established and an initial translation of Bylaws and Political Policies shall be performed by no later than April 30, 2018.



Truth and Reconciliation Commission: Final Report¹

Background:

The Truth and Reconciliation Commission recently released its final report. In the commission's final report, it listed a series of "Calls to Action" designed to address the issues raised by the Truth and Reconciliation process. These calls to action touch on a wide range of topics, including health, law, treaty enforcement, self government, and education. In particular, many of these relate to post-secondary education and impact on areas where the Canadian Alliance of Student Associations (CASA) is active in lobbying and advocacy.

Summary:

Many TRC recommendations already reflect CASA policy; notably those related to fixing the backlog of Post-Secondary Student Support Program (PSSSP) applicants, as well as eliminating achievement gaps between aboriginal Canadians and the national averages. These are areas which we can continue working on as an organization.

Others recommendations are not currently CASA policy, though they reflect federal areas of responsibility, such as providing funding for groups like SSHRC for research into issues surrounding residential schools and reconciliation. These represent issues that require examination and consultation with other interested stakeholder groups to determine the best paths forward in addressing.

The report also raises many issues that are provincial responsibilities; especially changes to curriculum to add awareness in law, health and other faculties of aboriginal issues, as well as offering instruction in aboriginal languages. These issues do take on a federal dimension depending on how the area of a first nations university is implemented, as well as when they take on a national, interprovincial dimension.

PSE-Related recommendations (out of 94 Calls to Action):²

7) We call upon the federal government to develop with Aboriginal groups a joint strategy to eliminate educational and employment gaps between Aboriginal and non-Aboriginal Canadians.

11) We call upon the federal government to provide adequate funding to end the backlog of First Nations students seeking a post-secondary education.

Analysis: These recommendations reflect our existing PSSSP policy, and our lobbying asks for the last several years. Closing gaps in education, especially higher education, remains a key goal for addressing gaps in quality of life, income, poverty and other issues.

16) We call upon post-secondary institutions to create university and college degree and diploma programs in Aboriginal languages.

Analysis: Course content issues will have to be settled at the provincial and institutional level, however it is an area where federal-funded pilot projects could potentially be created. This issue is also relevant to the area of federal funding for a first nations university.

24) We call upon medical and nursing schools in Canada to require all students to take a course dealing with Aboriginal health issues, including the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, and Indigenous teachings and practices. This will require skills-based training in intercultural competency, conflict resolution, human rights, and anti-racism.

28) We call upon law schools in Canada to require all law students to take a course in Aboriginal people and the law, which includes the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, Indigenous law, and Aboriginal–Crown relations. This will require skills-based training in intercultural competency, conflict resolution, human rights, and antiracism.

60) We call upon leaders of the church parties to the Settlement Agreement and all other faiths, in collaboration with Indigenous spiritual leaders, Survivors, schools of theology, seminaries, and other religious training centres, to develop and teach curriculum for all student clergy, and all clergy and staff who work in Aboriginal communities, on the need

to respect Indigenous spirituality in its own right, the history and legacy of residential schools and the roles of the church parties in that system, the history and legacy of religious conflict in Aboriginal families and communities, and the responsibility that churches have to mitigate such conflicts and prevent spiritual violence.

62) We call upon the federal, provincial, and territorial governments, in consultation and collaboration with Survivors, Aboriginal peoples, and educators, to:

- i. Make age-appropriate curriculum on residential schools, Treaties, and Aboriginal peoples' historical and contemporary contributions to Canada a mandatory education requirement for Kindergarten to Grade Twelve students.
- ii. Provide the necessary funding to post-secondary institutions to educate teachers on how to integrate Indigenous knowledge and teaching methods into classrooms.
- iii. Provide the necessary funding to Aboriginal schools to utilize Indigenous knowledge and teaching methods in classrooms.

Analysis: Similar to the issue of language specific PSE programs, the issue of curriculum development will require action at the provincial and institutional level, although actions taken towards the creation of a first nations university will impact it as well.

65) We call upon the federal government, through the Social Sciences and Humanities Research Council, and in collaboration with Aboriginal peoples, post-secondary institutions and educators, and the National Centre for Truth and Reconciliation and its partner institutions, to establish a national research program with multi-year funding to advance understanding of reconciliation.

Analysis: This area of policy does relate directly to federal areas of responsibility, though there is no current CASA policy related to creating any particular research programs within SSHRC or any other national research council. This issue could be an area for further CASA policy development, in conjunction with other interested stakeholder groups.

66) We call upon the federal government to establish multi-year funding for communitybased youth organizations to deliver programs on reconciliation, and establish a national network to share information and best practices.

Analysis: This particular policy recommendation related to PSE institutions owing to the fact that they will be involved in any eventual network on sharing information and best practices. PSE institutions will also have to be involved on a general level with the hosting of education events and forums.

77) We call upon provincial, territorial, municipal, and community archives to work collaboratively with the National Centre for Truth and Reconciliation to identify and

collect copies of all records relevant to the history and legacy of the residential school system, and to provide these to the National Centre for Truth and Reconciliation.

78) We call upon the Government of Canada to commit to making a funding contribution of \$10 million over seven years to the National Centre for Truth and Reconciliation, plus an additional amount to assist communities to research and produce histories of their own residential school experience and their involvement in truth, healing, and reconciliation.

Analysis: As with community-based events, records collection issues will likely involve higher education institutions as well, and require their cooperation and support. While this will have a greater impact at the provincial/institutional level, federal involvement will likely be required in the areas of funding and interprovincial coordination.

83) We call upon the Canada Council for the Arts to establish, as a funding priority, a strategy for Indigenous and non-Indigenous artists to undertake collaborative projects and produce works that contribute to the reconciliation process.

Analysis: As with funding for social sciences and the humanities, federal funding for arts projects will also have an impact on students at post-secondary institutions studying those subjects. This has not been a CASA ask in the past, but could be a point of advocacy, working with other interested stakeholder groups.

1.1 Background and Rationale

In partnership with the University of Alberta Students' Union (SU), studentcare.net/works has conducted a survey of SU members in order to obtain information and feedback on the SU Health & Dental Plan.

Survey findings will be presented to the SU Executive to assist in determining the level of student satisfaction with the Plan, as well as to gauge the health and dental care needs and preferences of its members, in order to inform and better shape the future development and growth of the SU Health & Dental Plan.

This report provides an overview of the survey objectives and methodology, presents the key findings of the survey, and makes a number of recommendations for consideration by SU. The report has been prepared by studentcare.net/works' research staff and is based on survey data collected by telephone from Jan. 26 – Feb. 10, 2015.

The survey provided students with an opportunity to comment on a number of key issues regarding the SU Health & Dental Plan, including Plan coverage. Students who opted out of the Plan were also given an opportunity to comment on the opt-out process.

1.2 Organizational Profile: studentcare.net/works

studentcare.net/works is Canada's largest provider of student health and dental plans and is the only organization in Canada that specializes exclusively in student health care.

Established in 1996 to serve the health and dental care needs of Canadian post-secondary students, studentcare.net/works now serves more than 650,000 members at over 40 post-secondary institutions and 70 student associations.

studentcare.net/works is a full-service health and dental plan provider, delivering a wide range of value-added services to clients, including brokerage services, Plan management and administration, communications, and research.

The company's head office is in Montreal, with service offices located throughout Quebec, Ontario, Saskatchewan, Alberta, and British Columbia.

2.1 Research Objective

The primary objective of the survey was to obtain feedback from SU members on their current level of satisfaction with the SU Health & Dental Plan, as well as their preferences with regard to specific Plan components. This feedback will inform future Plan related decisions by the SU Executive.

2.2 Survey Design

The SU was given the opportunity to review and provide input on the survey questions. In consultation with studentcare.net/works, feedback from members was sought in four key areas: communications, services, coverage, and opt outs.

- 1) Communications
- > Are students aware of their Health & Dental Plan?
- > How do students find out about the Plan?
- Did students consult a Plan Reference Guide and what did they think about the information included?
- Have students visited www.ihaveaplan.ca during the current school year?
- What do students think about the electronic communications they were sent about the Plan?

2) Services

- > In what medium do students tend to contact studentcare.net/works representatives?
- > Are students satisfied with the service they receive when making inquiries about the Plan?
- How long do students have to wait before speaking with a representative when visiting the on-campus office or phoning studentcare.net/works?
- > Do students download the ihaveaplan mobile app and make claims?

3) Coverage

- > Are students covered by another plan? If so, what kind of plan?
- How important are individual Health & Dental Plan benefits to students?
- > What benefits would students like to see covered by the Plan in the future?
- > What importance do students place on the Plan?
- > What do students think should be the top priority for the SU Plan in the future?
- > Do students support the continuation of the SU Plan?

4) Opt Outs

- Are students aware that they can opt out of the Plan?
- Did students choose to opt out of the Plan?
- Are students satisfied with the opt-out process?

Respondents were also given the opportunity to give additional comments at the end of the survey.

3.1 Sampling Methods

The survey was conducted from Jan. 26 – Feb. 10, 2015 in the form of telephone interviews lasting approximately 5-8 minutes, in an effort to obtain responses from a representative sample of SU members. The objective was to obtain 300 completed surveys. This goal was surpassed; 331 surveys were completed.

A random sample of about 3,000 names was generated from a list of students eligible for the Plan, including students who are enrolled in the Plan and those who opted out. Students were called at home during the afternoon and the early hours of the evening. This method of collecting data is the most effective way to contact students.

3.2 Representative Sample

The first section of the survey gathered general demographic information.

We have used the most recent enrolment statistics available in the UAlberta Facts section of the University of Alberta website¹, for comparison with respondent demographic statistics to demonstrate that a representative sample was obtained.

Status

The following chart compares the status of respondents vs. actual student statistics:

3.3 Margin of Error

With a student population of 31,648, a sample size of 331 SU members gives us a margin of error of +/-5.4%, 19 times out of 20.

This is an acceptable margin of error as the objective is to observe general trends (i.e. benefit preferences) and to look for potential areas of concern (i.e. coverage awareness). In either case, even the most extreme deviation possible (within +/- 5.4%) will not alter the conclusion that would be derived from the data. For example, the difference between whether 84.6% or 95.4% of respondents indicate that they are aware of their Plan coverage would not alter the conclusion that there is a high level of awareness of the Plan among students.

4.1 Key Findings

- An overwhelming majority of respondents (95.6%) think that the SU should continue to provide the SU Health & Dental Plan.
- Most respondents (82.7%) also feel that the current SU Health & Dental Plan is either 'very important' or 'somewhat important' to them.
- Three quarters (74.9%) of SU members were already aware of the Health & Dental Plan before participating in this survey.

Communications & Service

- Students learned about the Plan through a variety of media and resources. The most common methods for accessing information about the Plan are:
 - 1) Registrar's / Student Accounts office / Tuition bill / Bear Tracks (72.6%)
 - 2) Email (12.1%)
 - 3) Orientation events (7.7%).
- Of those students surveyed who consulted a Plan Reference Guide on campus or online (36.3%):
 - Over 95% found the information to be clear, useful, and sufficient
 - Over 88% found it engaging
 - These results indicate that SU members are highly satisfied with the new way in which information is presented to them in the Plan Reference Guide, as its design and content was recently updated.
- With regards to electronic Plan communications, over half (55.6%) of students surveyed have visited www.ihaveaplan.ca during the current school year.
- Of the students who received Health & Dental Plan information by email, 63.3% found it to be useful.
- Of the students who downloaded the ihaveaplan mobile app (12.5%), 51.6% made at least one claim. In addition, the overall response was positive: 81.3% were satisfied with their mobile claiming experience.
- Of the respondents who contacted studentcare.net/works during the school year for support (9.3%), a large majority (95.7%) were satisfied with the service they were given.
- 80.0% of respondents who dropped by the Health & Dental Plan Office on campus or who contacted studentcare.net/works by phone were served in 6 minutes or less.
- All respondents described the services as professional, and 95.7% thought the service was both courteous and helpful. This indicates that students have positive experiences when interacting with the Plan administrator and on-campus staff.

Opt-out Process

- Though most students (87.9%) were aware that they could opt out of the Plan, only a third (34.9%) of SU members who participated in the survey did in fact opt out.
- Almost all respondents who opted out found the process anywhere between fairly simple and very simple (98.7%).

Benefit Priorities

- Of a selection of the Plan's current health benefits, students gave the highest ratings (either very important or somewhat important) to prescription drugs (93.6%), followed closely by vision care (93.0%), and health practitioners (91.3%).
- Concerning dental benefits, students gave the highest rating to checkups and cleanings (94.8%), followed by fillings (90.7%), and wisdom teeth removal (88.4%).
- Generally, female respondents appear to value their health and dental benefits more than male respondents. For example, 87.2% of females surveyed consider prescription drugs a very important benefit, compared to 65.4% of male students, representing a 21.8% difference. The same trend can be seen for dental benefits; while 76.9% of males consider checkups and cleanings to be a very important benefit, 92.6% of female respondents listed the benefit as very important, a 15.7% difference.
- If adjustments were to be made to the Plan in the future:
 - Almost half of respondents (47.6%) indicated they would increase the cost only as much as necessary to maintain the current coverage.
 - Another 29.8% of students prioritized increasing the cost to increase the level of coverage.
 - Only 14.1% of students surveyed would risk a decrease in coverage in order to maintain the current cost of the Plan.
 - Even fewer (8.5%) students surveyed would prefer to decrease the current cost, even if that requires a decrease in coverage.

Comments

• When asked if they had other comments or feedback about the Plan, several respondents had suggestions concerning increased coverage. Please see Appendix A for a complete list of the participating students' comments.











5.0 RECOMMENDATIONS

studentcare.net/works presents the following recommendations to the SU Executive for consideration:

- 1. The majority of students surveyed appear to be satisfied with their current coverage, but if the SU is considering restructuring benefits, the most value should be placed on increasing prescription drugs and vision coverage, as well as dental coverage, as these were the benefits most students reported they would like to see increased.
- 2. As indicated by students' feedback, the majority of respondents felt that they would consider an increase in the cost of the Plan in order to maintain their level of coverage. Many were also open to an increase in the cost of the Plan in order to increase the current coverage. Less than a quarter of students wished to decrease coverage of the Plan to either maintain or decrease cost. The SU can take these figures into account if and when considering changes to Plan fees and overall structure.
- 3. To reflect student preferences on how they would like to receive information, the SU should consider targeted electronic communication. Though respondents find the Plan Reference Guide to be a useful source of information, the Plan could also be promoted more widely through electronic means, especially through email, which is the second most popular method students use to learn about the Plan. At least two thirds of respondents who already receive emails find the information to be useful and over half of respondents reported accessing the website to find out information about their Plan, displaying a general enthusiasm for electronic communication.
- 4. The responses from students regarding the ihaveaplan mobile app suggest that more could be done to promote the app to Plan members. Though only a small percentage of respondents reported downloading the app, over half of those that did had positive experiences, suggesting that the app could become a useful and more popular method of claims submission for SU members in the future.
- 5. Some respondents chose to leave comments at the end of the survey, the full list of which is included in Appendix A. To summarize, students asked for increased communication about Change-of-Coverage deadlines (specifically through email) and increased prescription drug coverage. The SU can take these comments into account when adjusting the Plan to best meet future students' needs and wishes.

I'm expecting this to be our last Council meeting of the year. I enjoyed working with all of you this year: seeing how much I reported to you this year, you probably know more about my work (which is a large part of my life now) than my parents do.

Here is a report on my duties to date:

1. University Institutional Strategic Plan (ISP)

I don't have much to report on the ISP this meeting, and the next ISP Advisory Committee is meeting in mid-May. The team leading the ISP is wrapping up consultations now, and working on incorporating them into a final draft.

2. Governance Review Task Force

I'll be sending a final report of the Governance Review Task Force to you on the late adds, as GRTF is meeting a day before Council to review all the work we've done this year and the report that it yielded.

3. Standing Committees: SURO, VP Search Committees, Vice Provost (Learning Initiatives)

The incoming and outgoing exec, including the incoming BoG rep, met with the Registrar's office for the last time this term.


President Khinda and I are also sitting on a VP Search Committee for the university's VP Finance and Administration (F&A) and VP Facilities and Operations (F&O). I won't be reporting much on this committee to protect the integrity of the search. What is public knowledge is that a search for candidates will be starting soon and there will be website live for anyone to redirect their questions to.

Lastly, President Khinda and I had a meeting with the Vice Provost (Learning Initiatives) Sarah Forgie, who has been great to work with this year. I have been glad to see the Provost's office be open to collaboration on priorities and issues for students.

4. General Faculties Council: GFC, Nominating Committee, FDC

At GFC, the ISP came up again. The most humorous comment I remember on the negative connation of tradition was that we "want to be on the leading edge of creating traditions", which I found to be very accurate!





Lastly at GFC, the Peter Lougheed Leadership College was briefly discussed. The main comments were not on the quality of the program for students, but the consequences of moving an entire unit away from GFC's purview into administration's, and what could happen if this became the norm for any initiative to not require stakeholder consultation.

GFC Nominating Committee met last week, which is quite similar to our own Nominating Committee. There we appointed student members to the standing committees of GFC. Next week GFC NC will meet to appoint staff members to the same committees.

Finally, FDC was a rather short meeting where we reviewed the delegations from GFC to FDC, per the review of academic governance requested by GFC. In particular, I learned that the Board's Long Range Development Plan guides the work of FDC, and the Board wants to ensure that GFC committees feature representation and commentary from academic staff and students on items of discussion.

5. COFA: Senior Board, APSA, BSA

COFA Senior Board met last week, and had a chance to review the first draft of the Institutional Strategic Plan just as Students' Council did last meeting. We also shared best practices on transition, which most FAs are heading into after elections.

As well, the BSA had their Awards Gala and APSA wrapped up their Pharmacy Awareness Month. I was glad to go to parts of their event and celebrate the great work students in the two Faculties have done this year!

6. Transition

VPA-Elect Banister shadowed me for a few meetings, in particular the Governance Review Task Force, Student Library Advisory Committee and COFA SB. There's a few more areas of the portfolio I need to go over with her such as COFA and COCA, and where there's overlap with the work of other executives. I'm sure we'll wrap it all up before finals begin.

7. Miscellany

I miss you all already.

Thanks so much for your time, your comments on my proposed policies and bylaw changes, and all the ideas you brought forward this year. I'm looking forward to the next time our paths cross. I know you'll all do great things!

Hello Council!

Sadly, this will be my last report to you all, but I've had a fantastic year learning and working with all of you!

TRANSITION

I am in full swing transitioning VP-elect Paches into his role. We meet roughly twice a week and go over different aspects of the job and his goals, and I've invited him to some external meetings as well, to get a better idea of the job and committees he'll be sitting on. We'll wrap up training just in time for retreat, and I am already incredibly confident that he will make a phenomenal VP Operations & Finance!

BUDGET

I will be presenting the 2016-17 budget to Council for approval at our last meeting. After looking over the budget and our expected revenues next year, the SU is in a pretty good place financially. While we are still finalizing staff costs, it appears the increase to the membership fee was enough to cover expected increases to wages over the next three years. Additionally, all of our businesses are projecting a profit for 2016-17, but I have kept the projections reasonable in the off chance that revenues drop. The SU's financial investments are all doing well, and have been largely unaffected by the economic downturn. We have been able to build up our reserves to comfortable amounts, and I am comfortable handing over our financial situation to the 2016-17 team, as we are starting to make more and more profit each year, which can be reinvested in stronger services and programming for students.

GENDER POLICY WRAP-UP

Like I announced last meeting, we have managed to remove gendered language from the University Calendar, and the Code of Student Behaviour will follow suit in April. All in all, four of the resolutions from the gender policy have been achieved, and six more are in progress. This has been a huge year for gender identity advocacy and a step forward in securing the rights of everyone, and I hope next year the momentum can be continued.



SQUIRE

We have partnered with an app to strengthen SUBtitles business! Squire is a company that assists with user-friendly textbook consignment, and we have launched with them. Download the app for iOS devices (Android coming soon, and maybe Blackberry for those stuck in 2008) before consignment starts again on April 4.

SELF-SERVE PRINTING

Upon a recommendation from Councillor Jason Wang, we are looking into bringing a self-serve printer to the lower level of SUB, for students to use when SUBprint is closed. We are currently finalizing the details, but it looks likely that we'll have one up and ready for the new term in September.

CAMPUS FOOD BANK

In April, I will be working with the Executive Director of the CFB to craft a new operating agreement with them, as they are one of our tenants. The last agreement we had ran from 2010-2015, and we haven't had time to rework it, so I hope to get that squared away and signed before my term ends, and line it up with the other contract timelines we have.

RATT SUMMER HOURS

To reduce expenses, RATT will be operating on a reduced schedule over the summer. It will be open for lunch Tuesdays through Thursdays, and open for lunch and dinner on Fridays. Dewey's will remain closed for the summer, as usual. Also, the SU will be trying a new project where RATT moves to the outside patio next to the atrium every few Thursdays for lunch. We're still working out the details, but I think this is an awesome way to use the new space and attract more people to an SU business!
