Dear Students' Council,

I'm hoping everyone has experienced a rejuvenating winter break and is ready to 'put their noses to the grindstone' in Winter Semester in 2019. Over policy committees 7 meetings this semester, we've achieved several objectives. Moving forward, we will maintain our meeting schedule of off-council Tuesdays from 5:00pm to 7:00pm (starting on January 15th). I'll now briefly summarize our activities, and motions.

Policy Committee's Activities during the Summer Semester

With eight policies that require renewal by the end of the 2018/19 Council term and three leftover policies that were not completed within last years deadline,

- General Plan
 - Continued moving forward on our general planning of working in 1-3 person teams, periodically checking in over the semester.
 - o Completed a light check-in on all policies on December 4th
- Policy Breakdown
 - 3 policies have been completely renewed Residence, Internationalization, Capital Projects
 - o 1 new policy has been introduced and passed Non-partisan
 - 3 policies have passed first reading Students in Governance, Quality Instruction,
 Experiential Learning
 - These policies will be coming forward for second reading very early in 2019
 - 5 policies are yet to be completed
 - To be completed in January 2019
 - Engagement expected very early in 2019.
 - CSJ review process highlighted additional avenues for adjustment. Expected very early in 2019.
 - To be completed later in 2019
 - Student Employment waited on CASA work pertaining to this topic to be completed and reviewed as a frame of reference. Moving forward in early 2019.
 - Equity, Diversity, and Inclusivity engagement survey completed over December. Moving forward in 2019
 - Food due to change in committee make up, this policy has been shifted to a new member (Ley). Policy is being updated and will come forward in 2019.
 - Reconciliation due to change in team make up, this policy has fallen behind schedule. Review and edits have occured, but work is ongoing.

Dear Council,

Welcome back! Hope everyone had a fantastic holiday and is ready for winter term 2019! I recently found out that I can still take some first-year courses, never maxed out my limit, so going to be in some classes just chilling.

Board of Governors

The board of governors met on December 14th and it was a fairly straightforward meeting. We are just starting to get into initial conversations at the board in regards to the 2019/2020 budget cycle and the next few weeks should solidify a lot of things.

Of note:

- The administration has released details in regards to the new budget model for the University will work and these changes will roll out over the next 3 years.
- As modelled and predicted last year, residence rates will increase by 5%. I gave a
 comment on how these changes must start to seriously consider the viability of
 residence if the surrounding market is much more accommodating, in paticular for upper
 year students. The meal plan will rise by CPI (approximately 2%)
- The Council of Post-Secondary Presidents of Alberta has released a position paper in regards to election priorities. Briefly, they are (1) increase capacity (2) financial support as grants (3) support for innovation, research, and skills training. I am currently exploring the possibility of directly supporting some of these positions, in paticular financial support for students.
- I have accepted a position on the newly created Board Governance Committee and look forward to continuing to recommend improvements to board governance at the UofA.

Campus Saint-Jean and President Turpin

VP Brown and I met briefly with President Turpin on December 17th to go over concerns in regards to funding at Campus Saint-Jean. We are hoping to see some coordination between the federal and provincial governments for funding to improve academic spaces at CSJ. President Turpin outlined a number of advocacy and funding options that the University is pursuing and looking forward to any results that may come from it.



Dean Katy Campbell (Faculty of Extension)

VP Bhatnagar and I met with Dean Campbell in regards to the potential for a closer working relationship with the Faculty of Extension. The Faculty has a lot to offer students, including all newly renovated student spaces downtown, expertise on subjects such as EDI, and research capacity for community projects. Will be following up in 2019 and hopefully establishing some research projects.

Things to Note

- The executive is heading to Calgary for the 9th and 10th for CAUS Counterparts Conference.
- Strategic planning committee continues to meet and first drafts of the document should be ready for circulation in the next few weeks.
- Antifreeze is on and I am getting pretty excited to judge a bunch of events!
- I intend to run some election workshops in late January and early February. If you or anyone you know is interested in speaking with me in regards to the elections, please email me! I am happy to meet, however, have to schedule in advance.
- Executive will have a half day retreat on Jan. 16th and a full day on February 1st. As well, there is SU mid-year meeting on the 18th. These meetings will be largely focused on strategic planning for the remainder of the year.
- I will be leading a session with councillor Bilak during Govweek called How to Lose an Election & Make Friends. I've done it a few times, should be a hoot!
- The BoG/Senate/GFC Joint Summit will be on Jan. 25th. This was an excellent event last year and thrilled to be advising its set up again this year.
- Thanks to early term investments in marketing, we are starting to see returns! Our social media presence has grown significantly, new universal branding is rolling out, and some super exciting giveaways and social campaigns are coming in January!
- Again thanks to early term investments we are the leader in the province for GOTV efforts! We could see an election called as early as February 1st, so I am thrilled by the preparedness and energy already developed.

Annual Maintenance Requirements

- Deferred Action
- = Deferred Maintenance
- Deferred Maintenance can look like:
 - Floods in spaces
 - Heating/Power loss in a building
 - Equipment failures leading to impacts on research.



Why should you care about Deferred Maintenance?

- Risk to the Institution, Academic Mission
 - Impact to student usage/occupancy
 - Impact to research outcomes
- DM is increasing unsustainably. Building system failures will be more numerous, more intense, and more often.



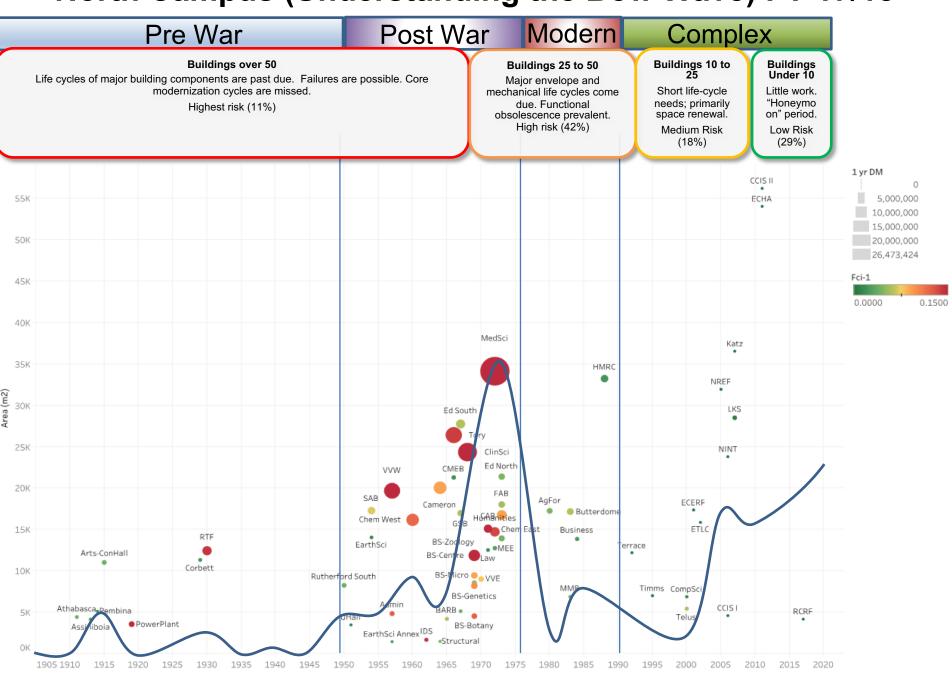

5 Year Maintenance Projection (North Campus) FY 2017/2018



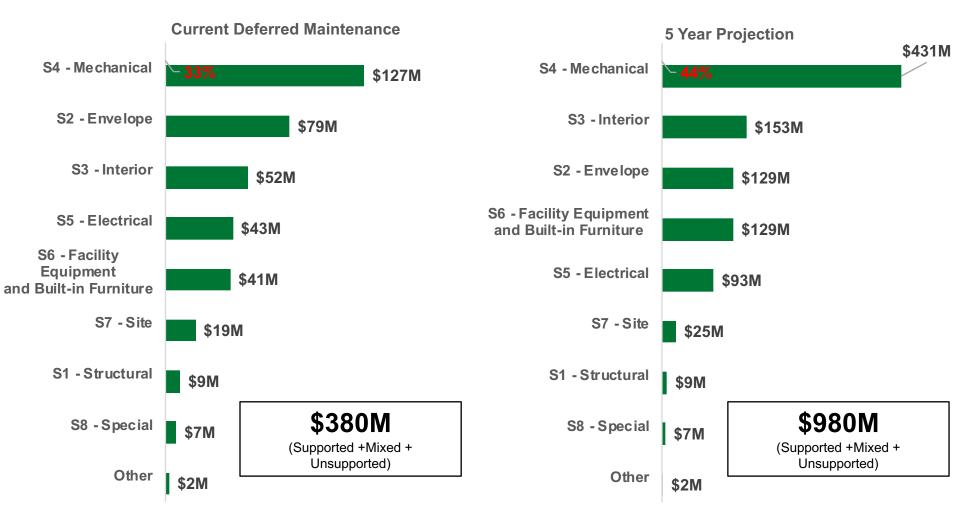

North Campus (Understanding the Bow Wave) FY 17/18

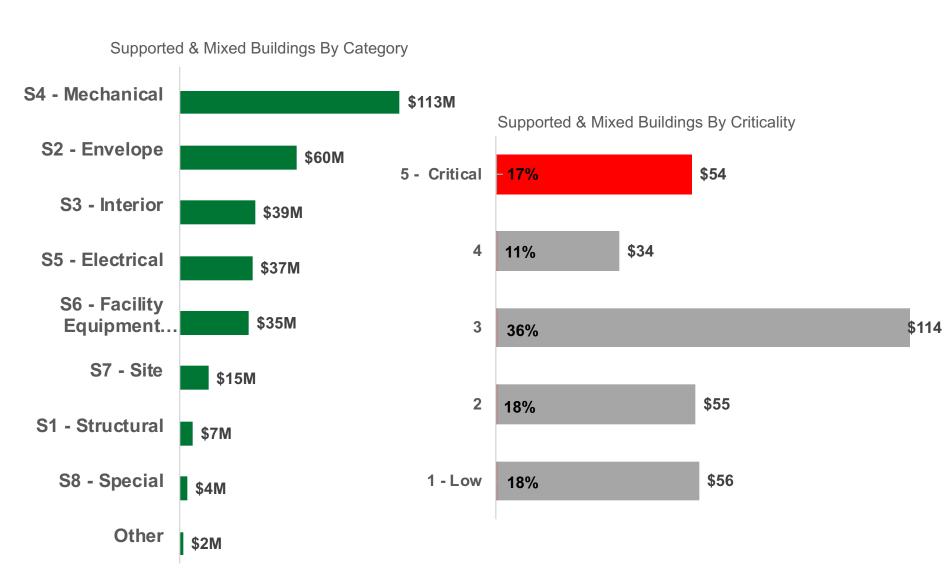
