The resulting student-controlled fund would help maintain and renew the SUB and other student spaces that are not eligible for government funding.

Augustana will be exempt from this levy.

Dear Council,

I'm certain I will be full of stories from the weekend by the time I get to council! I am attending a number of events on behalf of the UASU, including some GearWeek rock offs, this weekend and really looking forward to it.

Refocus Meeting

The executive team spent the morning of the 16th doing a full end of the year planning session, executive check-in, and team feedback session. I am very excited for the coming 3 months, as they will be a absolute dozy with things like the provincial elections, giveaways, and advocacy meetings.

Advanced Education Budget Consultation

VP Brown and I spent the afternoon with the Minister and stakeholders on the 15th to go over priorities for the upcoming budget. In brief, we reiterated that the next steps after Bill 19 are to increase support for student grants (Alberta has the lowest loan to grant ration in the country), the need for critical deferred maintenance at the UofA, and continued support for mental health services on campus.

Deferred Maintenance

Following the presentation to council, we have followed up with Facilities and Operations staff to go over the next steps for advocacy in regards to critical infrastructure and the Students' Unions role in that conversation. F&O continues to follow up on the deferred maintenance report commissioned by the UASU in 2016/17 and in addition, has drafted an information campaign to explain the current situation to the university community. On our end, we have





prepared a student spaces report that includes a rubric for assessing such spaces and that should role shortly. Finally, we are continuing to advocate for a 10% immediate increase in the Government of Alberta's 2019 budget cycle for deferred maintenance on campus.

AB Party Event

The Alberta Party hosted an event in Room At The Top on the 16th, at which I was able to speak at length to party leader Stephen Mandel and candidate for the riding Katherine O'Neil. Stephen Mandel gave a number of comments in support of the university community and was welcoming in regards to developing ageing infrastructure, research, and access to education.

CAUS Counterparts

I am sure that almost everyone has the story about executive and Robbie riding in the Ram 1500 all the way to Calgary and back in 24hrs, however, if you haven't yet, it was too much. Otherwise, the conference was excellent and it was fantastic to get updates from the rest of the province. My favourite session was in regards to breaking the perpetual cycle of student leaders burning out and correcting poor transition expectations.

To Note:

- The executive judged antifreeze and was in attendance at mixology. I was thrilled to judge mixology for the first time and had a wonderful evening!
- A draft of the strategic plan should be completed for mid to late February. My thanks to all those who have put in all of the hours so far.
- I am currently a item on the Henday Hall Skulk scavenger hunt and a lot of folks have been coming in to grab photos. Ivanhoe is still the better challenge IMO.
- GovWeek kicks of next week and councillor Bilak and I will be giving a presentation on how to lose an election and make friends. I am very excited as I last did this presentation as a councillor with President Fahim Rahman.
- The UASU is opening a new partnership with Flair airlines next week without giving any more away, I am very excited.
- News in regards to a significant change to tuition and mandatory fees in Ontario has put our provincial and federal advocacy groups hard to work. I would suspect many statements over the next few days.

3. Faculty Associations

ISSS - Science Week

The current President of AUFSJ has resigned and their VP Finance Eric Einarson will be taking over for the next few months. I've reached out and connected them to the SU (including Discover Governance) again and of course, we will support them in any way they need.

ESS - 77th Annual GEER Week

GEER Week was last week!! Amazing series of events. We will be going to Battle of Bands and I'm excited to check it out!

BSA Gala

President Larsen, VP Bourgeois and VP Brown and will be going to the BSA Gala! Super excited again!

OASIS Gala

Councillor Raitz and I will be MC'ing the OASIS Gala!! If you're reading this on Friday night, you can buy your tickets still <u>HERE</u> AND THEY ARE ONLY \$6!!!! There's gonna be a taco bar, Indian food and Thai food!!

4. Counterparts Conference

The entire Executive Team went to our Counterparts team last week, and it was great! I was happy to present on how other schools can **adapt Stride** and what the new **CAUS OER** ask should be.

5. GFC University Meetings

- GFC Exec
 - Closed the Pharmacy Reading Week File.
 - The PharmD candidate will not have a Reading Week in the 2020 academic years.

- They will have 2 wellness days instead, that will be reviewed on an annual basis.
- This was despite APSA's feedback but in a matter of 3 months, we forced the University to rescind a governance motion, to redo an entire consultation pathway and pass a new motion.
- We tabled the Terms of Reference for the Council on Student Affairs again to talk about the addition of a Grad Student Indigenous rep.
- WE WILL BE UPDATING THE USRI DATABASE AND I COULD NOT BE MORE EXCITED. Currently, the USRI data is so hard to read and students, therefore, are not connecting with their USRIs. I will be coming to Council for official consultations and I can't wait. I assumed this would be a multi-year project, but according to these timelines, it looks like one year. Future VPAs, take note!

- GFC ASC

- Approved changes to the PLLC. These changes include the semesterization of the PLLC courses, opening enrollment in the certificate to students after they have completed *24 credits which will enable students to take PLLC courses without having to enroll in the certificate, and making the Foundations of Leadership course (Int D 301) a prerequisite for the remaining PLLC courses. The primary motivation for these changes is to make the PLLC programming more accessible to students at the University of Alberta students and offer students more opportunities to gain both academic and practical leadership skills. I am looking forward to the implementation of these changes into the program and the SU is supportive of these changes going forward.

7. Stride

Members of Stride are going to be the SU Leaders of the future and it is so fricking exciting. I ran a Lunch and Learn session on how to navigate identity politics during elections and during Stride on Thursday, I ran a session on how to do effective one-on-ones and classroom talks.

6. Additional Things To Note

- An eClass Survey is being created in conjunction the SU, IST and CTL as I think it is really important for us to continue to understand how eClass serves students if we are spending thousands of dollars on it. Stay tuned!
- I've been meeting with several OER advocates on campus to help strategize about the OE Advocacy Group. I will bring our strategic plan to Council for early thoughts soon.

Dear Council,

It's crazy to think that we only have about 3 months left in this term! The last couple of weeks have presented some very interesting news that might affect a lot of what we do over the next few months.

1. Updates

- Alberta government Throne Speech and GOTV: The government has announced the Speech from the Throne for March 18. This helps us get a better idea of when the provincial election could be called, as in from the day after (March 19) to May 1. If it is called March 19, that means advance polling would occur on campus (in SUB) while students are still on campus. Again, no definitive date but I am hopeful for an earlier call. GOTV Coordinator Raitz has informed me that so far we have roughly 2400 students signed up to pledge, and we are on track for a successful score of 5000-6000 by election day!
- Advanced Education Budget Consultation: On January 15, President Larsen, myself and EAA Nelson attended consultations for the 2019 budget with the Minister of Advanced Education, his Chief of Staff, and other student leaders. It was a productive discussion where we discussed what should be next following the success of Bill 19, such as converting tax credits into up-front grants for low and middle-income students. We also discussed deferred maintenance and the growing need for structured provincial investment to address the issue.
- Ontario post-secondary announcement: On January 17, the Ontario government announced various measures targeted at tuition and fees. This announcement has prompted a large dialogue across the country. You can find their announcement here.
- **ASC tabling**: As the SU's representative to the Alumni Association, I am a member of the Alumni Student Council which primarily distributes granting money to groups for various projects, but also liaises with the Alumni Council. I spent some time tabling with them at clubs fair on January 16th to recruit new students who may be interested in applying to join. For more information on applying and what ASC does, click here.
- Campus Saint-Jean International Student meeting: On January 17th I also attended a meeting between about 60 CSJ international students and their Dean to discuss their education program and how it could be modified to better suit their needs. Dean Mocquais indicated that all new staff working for CSJ in practicum placement will have to take EDI training from the University, which I was pleased to hear.
- **Budget Town Hall:** On January 14, I attended the University's new budget model town hall, hosted by the Provost and VP Finance. They gave an overview of what changes the



model will bring forward, from space rental charges to faculties to how tuition is dispersed based on the classes students take.

- CAUS Counterparts: The Executive was in Calgary on January 9 & 10 for a CAUS counterparts meeting that included discussions on Bill 19, open education resources (thanks for VP Bhatnagar for her presentation!), managing mental health as an executive, and more. Overall many great discussions with our counterparts and I look forward to finishing the year with these fantastic folks.

2. Coming up

- Meeting with MP Dane Lloyd: President Larsen, myself and EAA Nelson will be meeting with Conservative MP Dane Lloyd to discuss student issues. He has previously reached out to us on the topic of campus security.
- **GovWeek**: Come check out the Provincial Election Forum (12pm on January 24) and the Exec Mixer (5:30pm on January 23rd)!
- CASA Mental Health Campaign: From January 30 February 1, CASA members across the country will be running the #StudentsLetsAct campaign to bring awareness to the federal government on mental health issues. Keep an eye out for broken heart paper cut-outs to write messages on, as we will be sending them back to Ottawa where they will all be presented to the government!

3. Things to Note

- **Antifreeze judging**: I had an amazing time judging the AntiFreeze dance competition on January 11 with the rest of the Executive! Those teams blew us away!

Keep yourselves warm this cold January! I'm not a coffee man myself, so a hot chocolate is always a good option.

5. Strategic Planning Committee





1 Facts

- 1. There is a broad variety of experiential learning opportunities including, but not limited to, work integrated or experiential learning such as co-ops, placements, practica, and field experience and non-integrated experiential learning such as work experience, undergraduate research, work abroad, and community service learning courses.
- 2. New learning experiences allow students to better learn, apply, and understand content within their studies.
- 3. Vital skills to programs and employment are developed outside of the classroom, and can be provided by experiential learning.
- 4. A Higher Education Quality Council of Ontario study confirmed that university students that participate in experiential learning opportunities have lower unemployment rates among full-time job seekers post-graduation¹.
- 5. Significant barriers exist towards participating in experiential learning such as:
 - Institutional barriers such as lack of information, academic program restrictions, student status, unsatisfactory grades, external policy barriers such as credit transfer agreements, counting of credits toward degree and/or general requirements.
 - 2. Financial barriers such as lack of funding for program development and lack of financial support for students.
- 6. Money dispersed through undergraduate research awards at the University of Alberta has not increased in recent years, falling behind to increases to minimum wage and other cost of living expenses.
- 7. There is a lack of opportunities and funding for undergraduate students to present their research at national or international academic conferences.

2 Resolutions

- 1. The Students' Union will advocate for increased experiential learning opportunities for all undergraduate students.
- 2. The Students' Union will advocate for flexible program requirements that allow all interested undergraduate students to participate in experiential learning opportunities irrespective of barriers related to their academic or personal background, including but not limited to race, gender, sexuality, religion, spirituality, ability, age, student status, satisfactory academic standing², and Aboriginal and/or international student status.
- 3. The Students' Union will advocate to the University of Alberta, government stakeholders, and other external organizations to ensure increased up-front funding and bursaries for students participating in local or international

- 4. The Students' Union will advocate for equitable financial and administrative supports for all undergraduate students so they have equal opportunity to participate in experiential learning opportunities.
- 5. The Students' Union will advocate for increased coordination between programs offering experiential learning, as well as a consolidated repository to connect students with experiential learning opportunities.
- 6. The Students' Union will advocate for increased holistic funding³ and opportunities for students to present research at conferences abroad.

Last Updated Jan 2019

1 Facts

- 1. The University of Alberta is a publicly funded research and teaching intensive institution and the core academic mission values "excellence in teaching, research, and creative activity that enriches learning experiences, advances knowledge, inspires engaged citizenship, and promotes the public good"
- 2. Quality in undergraduate instruction affects every student on campus and provides them with a positive, safe, memorable, and learning-rich experience throughout their degree.
- 3. Outstanding instruction in undergraduate education reflects positively on the University.
- 4. Excellence in instruction requires effective and clear communication and interaction between students and instructors.
- 5. Student feedback and evaluation of instruction provides students with a voice in their learning environment and can aid instructors to improve their teaching philosophy.
- 6. Smaller class sizes, with more accessibility to an instructor, are proven to increase the quality of instruction.
- 7. Quality instruction prepares students with transferable skills well-suited for the workforce and continuing educational endeavours.
- 8. Academic faculty members need access to high-quality, progressive professional development coupled with supporting policies relating to teaching and learning.
- Establishing a culture that promotes excellence in teaching requires institutional commitment, investment and innovation, including support for the scholarship of teaching and learning.

2 Resolutions

- 1. The Students' Union will advocate for continued and growing institutional commitment towards excellence in instruction, including support for innovative teaching practices and for the scholarship of teaching and learning.
- 2. The Students' Union will advocate for the continuous modernization of our curriculums to adapt to our dynamic environments.
- 3. The Students' Union will advocate for conditions that promote the importance of teaching at an institutional and grassroots level across our diverse campuses.
- 4. The Students' Union will advocate for the support of experiential and co-curricular learning integration with instruction to enhance student learning and incentivize instructors to adopt innovative and effective teaching strategies.
- 5. The Students' Union will advocate that the University recognizes the importance of professional development in an instructor's performance evaluation in Faculty Evaluation Committees.
- 6. The Students' Union will advocate that instructors be required to present evidence of their current and past teaching professional development experience as part of their annual review.
- 7. The Students' Union will advocate for increased and ongoing communication between students and professors through mid-semester teaching evaluations.

- 8. The Students' Union will advocate that the University of Alberta broaden the scope of teaching evaluations.

Students in Governance

Last Updated Jan 2019

1 Facts

- 1. Undergraduate students know their needs best.
- 2. The undergraduate population at the University of Alberta is diverse in its background, experiences, and composition.
- 3. Integrating student voices within committees and boards at the University of Alberta is essential to effective Undergraduate representation.
- 4. There are over 1000 representative positions filled by undergraduates at the University of Alberta.
- 5. Undergraduate student associations are autonomous organizations that exist to advocate for the students they represent. They derive their delegated authority through the Students' Union from the Post Secondary Learning Act.
- 6. Faculty and department support is valued by the Students' Union and student organizations.
- 7. Student representatives' activities supplement the educational experiences of students.
- 8. Undergraduate students are required to balance their academic, personal, and professional lives along with their representative activities.
- 9. Decisions taken with the best interests of the institution in mind must reflect the interests of its largest stakeholder, undergraduate students.
- 10. Undergraduate feedback is required and essential to inform University policies of their impact towards students on campus.

2 Resolutions

- 1. The Students' Union shall advocate that the University value undergraduate student representatives through fair and equitable treatment.
- 2. The Students' Union shall advocate for increased training and support for undergraduate student representatives both at the Students' Union and the University Governance level.
- 3. The Students' Union shall advocate for appropriate and fair academic accommodations for student representatives.
- 4. The Students' Union shall advocate for increased representation on committee and boards, whose mandates pertain to student issues.
- 5. The Students' Union shall advocate against the elimination of undergraduate student representative positions at any level unless doing so has direct benefits to students.
- 6. The Students' Union shall ensure the University fulfils their obligation to continuously consult student representatives on any issue academic, administrative, operational or otherwise that impacts students.
- 7. The University of Alberta shall refer to the Student Participation Handbook Process, a document outlining how to seek consensus with respect to the meaning and requirements of consultation with Undergraduate Students.

- 8. The Students' Union shall encourage faculties and departments to engage and support their student organizations, provided their independence is not perceived to be compromised and they continue to be driven by students.
- 9. The Students' Union shall actively communicate to the University the value of student representatives, and student representative groups in collegial governance and effective decision making for our campus community.
- 10. The Students' Union shall actively seek and create opportunities to reduce barriers to student participation in University governance, especially for underrepresented groups.
- 11. The Students' Union shall take steps to ensure that University committees provide value for student representatives and best utilize their role as a voice for students.
- 12. The Students' Union shall celebrate the hard work done by undergraduate student representatives across our campuses.

Bill 6: Changes to SU Student Group Oversight First Principles

Whereas

The Students' Union is responsible for student affairs under the Post Secondary Learning Act;

The University of Alberta is the one of the only Universities in Canada where student group oversight is not conducted primarily by the Students' Union;

The Students' Union must establish a fair, consistent, and robust process for student group recognition and oversight;

The University of Alberta does not wish to give up its own authority to recognize and derecognize Student Groups' ability to use the U of A name, insignia, and space;

Therefore

A new bylaw shall be drafted outlining a fair, consistent, and robust process for student group oversight which will include, at minimum, the processes for recognition, derecognition, complaints and investigations, and event registration.

The processes will include, a committee of Students' Council that makes final decisions about student group oversight, and a process for appeal to the DIE Board.

Existing bylaws that concern student groups and student representative associations will be amended or rescinded as necessary to agree with the Student Group Oversight Bylaw.

1 Facts

- 1. The University of Alberta has declared the importance of student involvement in building a great university.
- 2. The Students' Union defines that student engagement includes, but is not limited to, students participating in the community in multiple senses, including but not limited to:
 - a. Students getting involved in campus life through student groups and activities
 - b. Students having opportunities for input in shaping their community
- 3. A comprehensive and holistic student experience is one that balances exceptional academic and extra-curricular opportunities and experience, both on campus and in the larger community.
- 4. Involvement opportunities lead to improvements in the mental, physical, and social health on campus and the larger community.
- 5. Community and campus involvement actively develops the leadership qualities of students on campus.
- 6. The University of Alberta Student Participation Process Handbook (UASPPH) is a tool that was created conjointly by University administration, the Students' Union (SU) and the Graduate Students' Association (GSA) in 2013. This document sets out guiding principles, a continuum of student participation, and process with regards to engaging students on campus about changes and issues.

2 Resolutions

- 1. The Students' Union shall encourage the University to actively foster campus community and student involvement by investing in initiatives and opportunities that promote engagement.
- 2. The Students' Union advocates that the University identify and reward the contributions of students who actively strive to improve their campus and the larger community.
- 3. The Students' Union shall set an exceptional standard within the University community through engaging students on projects, policies, or processes that impact students on campus in an effective and influential manner.
- 4. The Students' Union shall encourage the University to engage students on projects, policies, or processes that impact students on campus in a way that acknowledges how student feedback impacts decision making.
- 5. The Students' Union shall use the UASPPH where procedurally and situationally appropriate in its own engagement processes.
- 6. The Students' Union may advocate for the review and renewal of the UASPPH when this is both necessary and logistically possible.
