2022-20/6 <u>OPEN FORUM</u>

POLENCHUK: Questions MONTEIRO, if the UASU is planning to organize any protests or strikes in regard to the tuition hike as well as the protests at the University of Calgary.

MONTEIRO: States that he is in contact with colleagues at the University of Calgary, However, things have been quite the contrary at the University of Alberta, where potential direct actions and other alternatives are being discussed.

Hopes that the upcoming BoG conference will bring greater clarification.

Adds that the SU is doing everything that they can for the proposed tuition increase, which would be the fourth increase in a row.

#### 2022-20/7 QUESTION PERIOD

LIU: Questions MONTEIRO regarding the student experience presentation. Wonders f there is a system in place for gathering the bad experiences that students have, and if so, how they are being reported and evaluated.

MONTEIRO: States that this program strives to gather and record all of the information that students have to offer, whether it be positive or negative.

Explains that this program is still in its early phases and that the SU is still debating how best to communicate that with the student body.

HUANG: Declares that this is his last day serving as a councilor and expresses gratitude to everyone.

ABBASI: Questions MONTEIRO about his opinion of the Faculty of Arts's religion course, RELIG 200: Religion of Islam.

MONTEIRO: States that FOGUE has actively been working on this concern and instead moves to have FOGUE answer this question.

FOGUE: Declares that she met with the MSA Execs to learn more about this concern. To ensure that this issue is brought up at a university level, the Executives will continue to discuss this issue in more detail.

MONTEIRO; Highlights his report, stating that the University would be making an inspiring statement addressing mental health in the next week or two, following the UASU's advocacy.

LIU: Gives his Farewell wishes to Councillor HUANG and encourages all council members to volunteer in the upcoming provincial election.

FOTANG: Appreciates LIU's volunteerism and enthusiasm towards the upcoming provincial election.. Mentions that council members might contribute as volunteers to

the Zine Magazine's article on the subject of postsecondary education affordability in Alberta. Council members can submit their writing, poetry, comics, and other artistic works. This is stated to be published in the winter term.

SHETTY: Comments that, while the University has engaged in communication with the UASU regarding the tuition hike, the document verification on BearTracks still costs an additional \$10 and states that there is a possibility that the University will still stick to the 6% increase despite student body concerns.

WATTAMANIUK: Remarks on the back-and-forth overtaking direct action in response to the tuition increases. Because of this, the UASU will also greatly benefit from developing relationships with the University.

ARSLAN: Believes that, although protests against tuition increases have been in the news for a while, they are of no use right now.

Remarks that the committee that makes choices that will impact the student body has a sizable representation from the UASU Execs and the BoG representative.

SHETTY: Asks whether Council is considering the same bills from the DIE Board that were amended simultaneously.

FLAMAN: Claims that this one doesn't, but that those issues have already been resolved.

HUANG: Speaks in favor of the first reading.

Believes that Council needs a long-overdue change, particularly in light of the recent successful elections. The Undergraduate BoG's appointment process was highly opaque and may have damaged many students' trust.

WATTAMANIUK: Strongly supports this bill.

SHETTY: Asks as to whether the 2017 DIE Board decisions were also taken into

account when the Bill made amendments.

FLAMAN: The Bylaw Committee is tasked with reviewing DIE Board decisions from the previous year and making modifications as necessary. However, claims he went back to 2015 to double-check all information.

LIU: States that during the committee meeting, he intends to bring solutions that go hand in hand with international students and newcomers to Canada. Believes that they should be included in the policy.

LIU: States that there is debate over whether this type of spending was appropriate for the money (for example, the BTR Event).

VILLOSO: Mentions that the formal Council task was to examine "finance management," which broadly encompasses some topics. But to have a general notion of the "spending money," the SU surveyed students via a Perks survey and aim to conduct another one soon to gain further insight.

DORSCHEID: Inquires about the value and expense associated with a KPMG report.

VILLOSO: States that working with KPMG is one choice, but if they give too high of a quote, the SU can look into alternative accounting companies.

FLAMAN: Asks whether it's possible to get a rough estimate and the difference if the SU had had this done in July. Both performance and scheduled audits would be beneficial for such a large organization. And since audits are ultimately simply numbers, money needs to be managed effectively.

ARSLAN: Questions if this will be included in the upcoming governance cycle.

VILLOSO: Responds, clarifying that she did not mean the SRA deadlines but rather the SU year (May-April). Internally, it begins in mid-May, and from August to December, it is presented to the audit committee for additional debate.

FLAMAN: Suggests that if there is no cost or estimate, the SU can set aside additional funds and release them if they are not needed. This will prevent any deficiency and make it more of a task for preparing ahead.

**VILLOSO/FLAMAN MOVE TO** add a motion to the Order Paper stating the following: rescind SC 2022-14/8h motion and instead direct the Audit Committee to work with KPMG to set up a plan for the completion of a performance and compliance audit for the upcoming Audit cycle recognizing the previous motion to complete a financial management assessment of the SU.

LIU: Thinks that more time should be given to candidates so that they can consider applying for executive positions. Adds that the campaign period is shorter by just one

week. There are doubts about whether the packages can be released early because elections occur in the second week of March.

KOOHKAN: Says he's here to listen to the Council's recommendations and viewpoints.

Adds that if the nomination deadline is extended to 30 days from now, it will fall on the first day of Reading Week, when faculty support won't be accessible. This year, some internal problems led to the delay.

HUANG: Asks how significant the errors are in the nomination packages.

MONTEIRO: Answers that the errors were related to bylaw compliance. If Executive elections were to be extended by a week, it would conflict with Council and GFC Elections before continuing into the first week of April. Because this is also the last week of courses and the start of final exams, student involvement will, inevitably, be low.

KOOHKAN: If the Candidates' Meeting were to take place on March 27, the election would then be delayed to March 2 or March 3—a breach of the Bylaw, which stipulates that elections must take place during the second week of reading week. They will have roughly two weeks to prepare as the candidates' meeting will be conducted on February 16.

Agrees with MONTEIRO that the dates conflict with the Council and GFC elections.

HUANG: Asks about what would happen if the Council and GFC Elections were held before the Exec Elections.

KOOHKAN: States that it violates the Bylaws.

DHILLON: Thinks that Council should shorten the nomination deadline. The Candidates will then have an additional week to prepare their banners and posters.

FLAMAN: Declares that we are attempting to select the alternative with the lowest potential for harm. We may decrease the nomination deadline since students serious about running for open positions will have made up their minds before these packages are distributed.

OJO: Is hesitant to lower the time frame because there is still much work to be done.

KOOHKAN: Considers that a strong line of communication between the election office and the SU is necessary to stop future conflicts.

REGMI: Considers moving the nomination deadline to two days before the candidates' meeting.

KOOHKAN: The Candidates' Meeting took place the day before the deadline in one of the prior years. However, we must hold the meeting on a different weekday rather than a holiday weekend.

VILLOSO: Remarks that she thought having seven days of campaigning was a void from the previous year and that it was too much time. This year, the maximum number of days for campaigning should be around ten.

Proposes moving the nomination deadline to Monday, February 27, which falls after Reading Week.

KOOHKAN: Suggests that the election season would be a rush and that student engagement has historically been minimal.

DHILLON: Agrees with VILLOSO. Since the candidates can only begin using the resources after this specific meeting, Doesn't support the concept of having the candidates meet on the 27th. Suggests cutting the package's delivery deadline.

FLAMAN: Agrees. Although the candidates' meeting takes place before reading week, which provides the pre-campaign days of roughly nine days, the dates have not been expressively described. Therefore, starting your promotion on Monday morning following reading week is a fantastic idea.

KOOHKAN: One approach to this would be to hold the Candidates' Meeting and the deadline for nominations on the same day: February 15. The candidates can prepare for their campaigns throughout Reading Week and they can then run their campaigns through March 8. But in essence, doing so would imply moving up the package deadline.

FLAMAN: Asks KOOHKAN if he received full training from SU and a proper transition.

KOOHKAN: Confirms that that was the case.

VILLOSO/LIU MOVE TO return to Committee of the Difference CARRIED 23/00/00

**SHETTY/REGMI MOVE TO** extend until the end of the motion. CARRIED 19/00/04

SHETTY: Declares that whatever course of action the Council and the Elections Office decide, Council doesn't want any deadlines that coincide with exam time or anything that would damage Council's reputation.

VILLOSO: Admits that the SU shouldn't punish the students because, in the end, it was SU's fault for the nomination packages contravening bylaws. Campaign season is a busy time, and students have a significant amount of work to do. Giving the

candidates access to documents before the meeting is one option.

USSERBAYEVA: Agrees with VILLOSO; everyone has a right to take their time before making a decision. It would be great if the students had a week to prepare psychologically.

DHILLON: Holding it on the 27th wouldn't go against any bylaws, but we don't want people making banners two to three days after the candidate's meeting.

SHETTY: Questions if everyone who fills out the nomination package is allowed to be considered as a candidate. Also, questions if having access to the materials would have any unfavorable consequences, and if their expenses would be covered.

VILLOSO: States that the \$550 allocated to each candidate to operate their entire campaign has already been budgeted.

MONTEIRO: Adds that the CRO office ensures that it reviews the packages before giving them a chance to be candidates.

KOOHKAN: Answers to VILLOSO stating that candidates would have access to the universal materials more extendedly if their packages were submitted sooner.

REGMI: Asks how long it will take to make any changes.

KOOHKAN: States that a decision will be made soon (i.e between 24-48 hrs).

ARSLAN: Recommends an e-vote if this is a pressing matter, as Council is barely maintaining quorum and notes that a vote in Council wouldn't be fair to those members who left at 9 due to prior commitments.

Council loses Quorum. Meeting Ends.

Hope you are doing well!

Here are some updates from me:

#### **SLAC**

The **Student Library Advisory Committee** had its first meeting. It was a great meeting discussing all the different services that the libraries provide and how those can be improved and enhanced. This committee is composed of students from different faculties and levels of study, so it is awesome that they are able to share feedback and experiences which helps the libraries in making changes. We also had a discussion about Open Education and ZTC and I got a chance to share some information around this with the committee.

#### **ZTC**

We received the number of ZTC registrations from the Registrar's Office for the winter term. The number is higher than any term from the past with more than 1100 unique courses and more than 800 professors registered.

I also had a check in meeting with the digital Initiatives Projects Librarian to discuss the next steps in expanding ZTC.

#### SS-SMC

Student Services- Service Management Committee met and we discussed the student services catalogue and the ways to make it more accessible for the sake of effective service delivery and to guide our community. I advocated for adding more information to it which would guide students better to benefit from the services. And we discussed the ways of getting feedback from students after they received any service and that can be posted on the website to help other students.

#### GFC

These past weeks, I had all the GFC committee meetings where I continue advocating for all the changes to make the student experience better. For instance, at CLE (Committee on the Learning Environment), I raised the concerns reflected in the Indigenous Student Success Survey Report.

### CoFA

We had our monthly meeting of CoFA Advocacy Board and shared some survey reports (Work Experience survey report, Academic support services survey year over year report and Ombuds annual report) with them and had a discussion about the GOTV (Get Out the Vote) campaign. The Senior Board could not meet because of scheduling issues and will be meeting in coming weeks.

## SUB Planning Committee Terms of Reference

## Mandate

- 1. The SUB Planning Committee shall exist as a subcommittee of the Executive Committee.
- 2. The SUB Planning Committee shall:
  - a. Review student needs in the context of the facilities and services provided by the Students' Union Building;
  - b. Develop a building master plan (or, where one exists, propose amendments to plan), covering areas such as:
    - i. The mission, vision, and program of SUB;
    - ii. Space assessments and allocations;
    - iii. Proposed renovations and upgrades to SUB;
    - iv. Initial financing strategies for renovations and upgrades managed by the Students' Union;
    - v. Developing design guidelines in areas such as wayfinding, accessibility and inclusion, decor, and other matters as appropriate.
  - c. Consult with students and other stakeholders as required regarding items within this mandate.
- 3. The Committee shall make recommendations on matters pertinent to its mandate to the Executive Committee.
- 4. The Executive Committee may, at its discretion, forward those recommendations, along with any feedback, to the appropriate Students' Union and University governance bodies.

## **Standing Orders**

5. The SUB Planning Committee may propose amendments to these standing orders, by a simple majority vote of the Committee, to the Executive Committee. The Executive Committee may accept, reject, or modify these amendments.

## Membership

- 6. The membership of the committee shall consist of:
  - a. President of the Students' Union;
  - b. Vice President (Operations & Finance) or designate, who shall act as chair;
  - c. Vice President (Student Life) or designate;
  - d. Two Students' Councillors;

- e. A member of the Sustainability and Capital Fund Committee; and,
- f. A minimum of two and a maximum of three undergraduate students-at-large, one of whom shall be an First Nations, Metis, or Indigenous student;
- 7. The following staff of the Students' Union and the University shall be considered non-voting members of SUB Planning Committee:
  - a. General Manager;
  - b. SUB Planner;
  - c. Director, Conferencing and Events (acting as interim Facilities Manager);
  - d. Assistant General Manager; and
  - e. Up to four representatives of the University's Facilities and Operations department to act as resources in areas such as space planning, architecture and design, and building program..
- 8. SUB Planning Committee shall, at its discretion, recommend to Executive Committee the removal of a voting member who has been absent without appointing a proxy for three meetings.
  - a. SUB Planning Committee may also recommend a member be dismissed from the committee if a voting member is failing to perform their duties as stipulated in these Standing Orders.

## Chair

- 9. The Chair of SUB Planning Committee shall be the Vice-President (Operations and Finance).
- 10. In the event that the Chair is absent at a meeting of SUB Planning Committee, the Chair shall appoint at their discretion another member of the committee to serve as interim Chair for the duration of the meeting.
- 11. The Chair's responsibilities shall include, but are not limited to:
  - a. Facilitating each meeting according to the approved agenda;
  - b. Moderating debate and conversation at each meeting of SUB Planning Committee;
  - c. Responding to questions from members of SUB Planning Committee in a timely fashion and providing the appropriate information;
  - d. Assigning duties to members of SUB Planning Committee in order for the committee to fulfill its mandate; and
  - e. In conjunction with the Manager of Administrative Services:
    - i. Providing a location for each meeting;
    - ii. Preparing and distributing agenda packages at least one day prior to the meeting; and
    - iii. Ensuring other logistical needs of SUB Planning Committee are met.

12. The Chair of SUB Planning Committee shall use their discretion in administering an informal style of Robert's Rules of Order to conduct the business of the committee.

## Meetings

- 13. Quorum for a meeting of the SUB Planning Committee shall be 50% of committee membership with at least one non-Executive Committee member.
- 14. All meetings of the SUB Planning Committee shall be coordinated by the Chair on an as-needed basis, provided that members are given 72 hours' notice of a meeting.
  - a. Five voting members of the SUB Planning Committee may call a meeting, provided that members are given at least 72 hours' notice.
  - b. SUB Planning Committee may call a meeting without notice, provided that there is unanimous consent from all voting members of SUB Planning Committee.

## **Member Responsibilities**

15. All members shall ensure the security and confidentiality of sensitive information that comes into their possession by virtue of their membership on the SUB Planning Committee.

## **Proxies & Guests**

- 16. Voting members of the SUB Planning Committee may not delegate a proxy to meetings of the SUB Planning Committee. Non-voting members may delegate a proxy to meetings.
- 17. All members of Students' Council that are not members of SUB Planning Committee are permitted to attend SUB Planning Committee meetings as non-voting members, and shall be granted all speaking turns a member of SUB Planning Committee would have.
  - a. These members are permitted to be present for in-camera sessions.
- 18. Members of the Students' Union (guests) are permitted to attend SUB Planning Committee meetings as non-voting members, and shall be granted speaking turns at the discretion of the SUB Planning Committee Chair.
  - a. These members are not permitted to be present for in-camera sessions, unless allowed by a two thirds majority vote of the SUB Planning Committee.
- 19. Any professionals such as architects or engineers that the Committee consults with on the preparation of the plan shall have full speaking rights and are permitted, at the discretion of the Chair, to be present for in-camera sessions.

## **Committee Administration & Record**

20. The Manager of Administrative Services, or their designate, shall:

- a. Book meeting rooms for each meeting of SUB Planning Committee;
- b. Schedule Minute Takers for each meeting of SUB Planning Committee;
- c. Create agendas for each meeting of SUB Planning Committee, under the guidance of the Chair;
- d. Notify members of the committee of meetings;
- e. Distribute the agenda and minutes to members of SUB Planning Committee.
- 21. SUB Planning Committee shall have a written record of its votes and proceedings from each meeting made available publicly.
- 22. If a Minute Taker is not present at a meeting of SUB Planning Committee, the Chair shall assign the task of recording minutes to a member of the committee.

## Purpose

The Students Union/Executive Committee issuing a condemnation of Frances Widdowson's racism and calling on the Minister of Advanced Education to apologize for his remarks defending her right to speak on campus despite her views being hateful and racist.



### **Executive Summary**

Frances Widdowson, a former Mount Royal Professor who was fired from the university after it was revealed she had a history of making racist comments towards Black and Indigenous students, most notably denying the harms of Residential Schools, was originally scheduled to speak at the University of Lethbridge on Wednesday, February 1st. After originally declining to cancel the speech, the University of Lethbridge ultimately decided to cancel her speech and not allow Widdowson to speak on campus. Shortly after, the Minister of Advanced Education wrote out a statement saying that he was going to take action to defend free speech on campus, even if the person's views were offensive, directly using Widdowson's cancelled speech as an example.

Prior to being fired, Widdowson had been a tenured professor at MRU in the department of economics, justice and policy studies. She made headlines in 2020 after saying the Black Lives Matter movement had destroyed the university and that there had been an educational benefit to residential schools.

That prompted more than 6,000 people to call for her firing via a petition. She was dismissed from the Calgary institution in late 2021. At the time, she attributed her firing to her criticizing "woke ideas" and suggested that "identity politics" had prevented people from discussing ideas at the university.

Since then, she's made such subjects a regular part of her public appearances.

"Earlier today, I learned of the University of Lethbridge's decision to concel a controversial guest speaker who was scheduled to speak later this week. I understand past comments made by this speaker are controversial, but I believe it is important for our universities and colleges to foster a strong culture of free speech and diverse viewpoints, even when those viewpoints are deemed controversial, or even offensive, barring speech intended to incite hatred ar violence of course.

I will be announcing new steps to strengthen free speech on Alberta's post-secondary campuses in the near future. It should be for students, not university administrators, to make the final decision about whether to listen to a speech or not.

I would also note that the above comments should not be construed as agreement with any past comments made by the speaker in question."

My name is Hanum Ali and Tim writing to you today alongside several elected student leaders and students that are concerned about your commentary. I'm an elected student leader, university student and a community organizer. Mian Regmi and Abdul Abbasi are elected student leaders with the University of Aberta's Student's Union and members of General Facultes Council. Any Mendenhail is a student leader from the University of Lethoridge who served as the VPSA and formed the Student Action Assembly. Collectively, we are writing to you calling upon action from your ministry.

We are writing to you today as we are severely concerned and deeply troubled by the comments that you have made regarding the University of Lethbridge's decision to cancel a talk that was scheduled to be hosted by Frances Widdowson. In 2021, after students and faculty raised concerns with the comments that Widdowson had made regarding residential schools. Black Lives Matter, transpender rights and more. These comments are especially concerning as all students have a right to feet safe on campus.

Close to 2.000 students via a petition shared their concerns with the University of Lethbridge about their decision to give space to Frances Widdowson. Her presence on any campus endangers students well being and their safety. This was made especially clear when Widdowson threatened the University of Lethbridge after they listened to community members and cancelled the talk. As student leaders, we have a responsibility to advocate for our campus to be a safe space for all students. The comments coming from you are concerning and we are specifically concerned about these comments.

"I understand past comments made by this speaker are controvensial, but I believe it is important for our universities and colleges to foster a strong culture of free speech and diverse viewpoints, even when those viewpoints are deemed controvensial, or even offensive, barring speech intended to incite hatted or violence of ocurse," said Nicolaides in a Tuesday statement.

As student leaders, we fully agree that free speech is an important part of academia. However, free speech isn't an excuse to allow for hate speech. When we allow hate speech to fester in our communities on campus, they have dangerous results. Campus and academia must be a safe space for every single student to participate in. While fostering a storig outure of free speech is important, we can't allow an individual to foster hate and misinformation regarding residential actions and the Black Uses Matter movement.

I have attached some further commentary from some of the signatories of student leaders and students from across Alberta that are severely concerned about your commentary.

"I'm especially troubled by your comments as this speech was supposed to come on the first day of Black History Month. Platforming a person who has suggested that "Black Lives Matter ruined her University." In BHM is wrong. Furthermore, I'm especially concerned about her

#### Dear Council,

This is intended to serve as an outline of the fiscal priorities of the University of Alberta Students' Union for the fiscal year beginning May 1, 2023 and ending April 30, 2024. This document is legislated under Students' Council Standing Orders, and is mandated as a responsibility of the Vice-President (Operations and Finance) under Bylaw 1100.

#### <u>Preamble</u>

The Students' Union is guided by our Strategic Plan. Our mission is to serve, represent, and engage students.

We offer services and businesses that provide for the needs of students. We organize events and programs that build community on campus. We advocate for student interests to the University, government, and the greater community.

We provide and create space for students to relax, study, and socialize.

#### Our guiding values are:

- Do what's right, not what's easy
- Inspire change for the world
- Act with unbridled compassion
- Always keep moving
- Learn from the past to improve tomorrow

#### Our critical success factors and goals are:

Empowering our students

- Inform, expand, and support students' rights.
- Prioritize equity, diversity, and inclusivity and the removal of barriers in order to ensure that student leadership reflects the student body.
- Support and advocate for the adoption of more versatile, effective, and fair discipline and dispute mechanisms.

### **Fiscal Considerations**

Budget principles shall outline the basic direction for the creation of the budget. The following adjustments lie outside of budget principles and, while they should be considered in the submission, are at the sole discretion of Students' Council and/or any other legislative body outlined in Bylaw:

- Alberta Consumer Price Index (ACPI) calculations for 2021-22
- Total membership revenue based on a blend of enrolment estimates and historical enrolment trends put forth by the University of Alberta in 2021
- Changes to the Post-Secondary Learning Act by the Government of Alberta
- Students' Union Membership Fee increases (beyond inflation) and decreases
- Students' Union Dedicated Fee increases (beyond inflation), decreases, creation, and/or elimination

### <u>Principles</u>

- 1. In the event that a section of this document conflicts with any other section, the Finance Committee shall identify such a conflict and propose any necessary changes in the presentation of the final budget.
- 2. Total operating and capital expenditures will not exceed the amount of total operating and fee revenues. The only exception to this would be Council approval on a budget that includes multi-year projections to resolve any deficits. (edited)
- 3. Capital budgeting shall be apportioned at the discretion of the Financial Controller and Vice President (Operations and Finance) after the operating budget has been created. Using the set amount of capital funds allocated, decisions for use of capital funds shall be made by the Core Manager responsible for each unit.
- 4. Growth in a department shall be offset by a variety of strengthened revenue streams in that department, where possible.
- 5. All departments must work within the mandate of the Students' Union; activities or operations deemed to be beyond its scope shall be eliminated. The 2024-28 Strategic Plan shall be used as a guide to assess the relevance and value prior to such decisions. (edited)
- 6. External entities such as dedicated fee units and operating grants shall be managed as per existing Students' Union Bylaws and applicable contracts.
- 7. Unless otherwise noted, operating and fixed costs increase at a rate relative to the previous fiscal year no higher than inflation for the province of Alberta; the activity of the Students' Union will continue in a manner consistent with the precedent set in previous fiscal years.
- 8. The Students' Union shall implement all necessary financial restraints and audits as required by the Post Secondary Learning Act and its own Bylaws and Standing Orders.

- Unionized staff costs shall change as specified in the collective agreement with CUPE (Canadian Union of Public Employees) Local 1368. Out-of-scope staff are entitled to a Cost of Living Increase and a merit increase in accordance with their respective employment agreements and appraisal outcomes. (edited)
- 10. Dedicated fees shall increase in accordance with the Students' Union Regulation 410, as set out in the 1992 referendum approving increases based on the Alberta Consumer Price Index (ACPI). Based on estimates, ACPI for 2023-24 will be approximately 6.0%. (edited)
- 11. Every effort shall be made to keep the operating fee increase less than ACPI. (new)
- 12. Funds will be allocated to develop non-fee reliant revenue sources and fundraising capabilities.
- 13. Resources shall be made available for recurring projects of the Executive Committee, provided they can show the need for such resources and consistency of such projects.
- 14. Resources will be made available for the Executive Committee to build positive relationships with important stakeholders. (edited)
- 15. Resources shall be allocated to ensuring that Students' Council members have sufficient opportunities for training and engagement to make informed decisions. (edited)
- 16. Resources shall be allocated to ensure the effective operation of student governance structures during and after governance restructuring. (edited)
- 17. The Students' Union business units shall strive to avoid budget deficits prior to cost apportionment allocations. All reasonable attempts to maximize the profitability of these business units, consistent with the mandate of the Students' Union as a service provider, shall be made.
- 18. The Students' Union shall allocate resources toward branding and engagement improvements.
- 19. The Students' Union shall continue to allocate resources toward enhancing the content on digital platforms and digital and media assets. (edited)
- 20. The Students' Union should continue to invest in its volunteers, student and professional staff through professional development options and enhanced training.
- 21. The Students' Union will continue to invest in taking steps towards reconciliation including the continued allocation of funds for work on and completion of the 2019 Aboriginal Relations and Reconciliation recommendations and other projects with a focus on reconciliation. (edited)
- 22. Resources will be allocated to support the Students' Union's efforts to make its operations, building, and services environmentally, socially, and fiscally sustainable.
- 23. The Students' Union shall allocate resources to prioritize equity, diversity, and inclusivity to ensure that it represents the diversity in its membership.

- 24. The Students' Union shall allocate resources towards initiatives that promote student health and wellness.
- 25. Funds shall be allocated for the Students' Union Building Master Plan and the evolution of the building to better accommodate students.
- 26. The Students' Union shall allocate 20% of the SCF Green Fund to Indigenous-led and focused projects. (new)
- 27. The Students' Council budget shall include \$10,000 of unallocated funds to use for projects selected by the next Students' Council. (new)
- 28. The Students' Union shall allocate resources towards exploring possible student discount programs to ameliorate the cost of living for students. (new)
- 29. The Students' Union shall allocate additional funding to further support student groups. (new)
- 30. The Students' Union shall make room for allowances for potential Councillor compensation, to be passed only in tandem with a comprehensive governance reform and accountability measures. (new)
- The Students' Union shall explore the possibility of creating a volunteer bursary program. (new)
- 32. Resources will be made available to improve the safety and security of SUB. (new)
- 33. Resources will be made available to conduct a <u>Performance Audit</u> and a <u>Compliance Audit</u> in conjunction with the annual Financial Statements Audit (2023-24 only). (new)
- 34. The Students' Union shall allocate resources towards displaying art in SUB, including Indigenous and student art. (new)
- 35. The Students' Union shall allocate resources to exploring ways to expand mental health services available to students. (new)

#### Removed from 22/23:

- 1. Resources shall be made to engage and support Students' Council members in its efforts to make informed decisions.
- 2. The Students' Union shall allocate resources to provide sufficient support to student governance objectives.
- 3. Resources shall be made available for the sponsorship of events related to Students' Union activities that do not have a pre-existing Students' Union funding source.
