The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwacîswâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsítapi (Blackfoot), Métis, Dënesųłiné (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?

As student leaders, this is our opportunity to share the pressure points and concerns that students are experiencing and ask questions of the university as to why, where and how revenue will be allocated.



THE UNIVERSITY'S INCREASING COST DRIVERS



WHAT DOES MY TUITION COVER?

Tuition covers all expenses related to instruction at the university, including

- Instructor salaries
- Creation and maintenance of classrooms
- Creation and maintenance of study spaces
- Supplies related to instruction that are consumed during instruction and not retained by the student (materials owned or leased by student are covered by other fees)
- Utilities
- Maintenance of research enterprise that supports instruction
- Libraries

\$20M (4.9%) of tuition revenue goes directly into student financial support (23/24)


WHAT IS THE PROPOSED **TUITION INCREASE** FOR 2024/25?

A domestic tuition increase of 2.0% is proposed for 2024/25

Proposal will include 15% incremental offset dedicated to student financial support.

Legislated tuition cap creates funding gap



P. 06 Legislated tuition cap creates funding gap

- The difference between a 2% domestic tuition increase and an increase at CPI (4.97%) creates a \$6.7M revenue gap for the University.
- It also means **\$1.1M** less funding to allocate to student financial support, based on our proposed 15% incremental offset.

Exceptional Tuition Increases

Per government guidance the proposed 2% increase will also apply to previously approved Exceptional Tuition Increase (ETI) amounts.

ETI revenue can only be used for initiatives to improve program quality.

2024/25 INTERNATIONAL TUITION

- 2024/25 Cohort Tuition was approved in March 2023
- Proposal for 2025/26 cohort based tuition is being developed based on:
 - **Research**-listening to the voices of prospective students and analysis
 - Student input-continued commitment to student needs
 - **Cost drivers** of program delivery and government legislation
- International tuition proposals and associated tuition offset for 2025/26 to bring back to this forum.

INTERNATIONAL GRANDPARENTED STUDENTS- COHORT 99

- Bill 19-an Act to Improve the Affordability and Accessibility of Post-Secondary Education, included a requirement that International students receive a tuition guarantee.
- Program-based tuition model for international students who were admitted starting in fall 2020
- This did not impact 5,700 international students who were already enrolled coded as cohort 99
 - These students were informed that they will stay on the registration-based model until Fall
 2024.
- The Office of the Registrar has communicated with students from cohort 99 who remain to ensure awareness of impact.
 - This includes 485 graduate and 501 undergraduate students
- Different outcomes are being actioned for students depending on their circumstances.

Selection of Key Messages

- Structures to advance EDI varied, reflect resources
- Need multiple processes to collect usable data
- Despite many individual units, portfolios having developed activities and processes using an EDI lens, reporting not yet systematized
- A variety of EDI resources, initiatives have been developed; more support is needed to ensure opportunities are available in all areas
- Internal, external partnerships instrumental
- Structural, interpersonal barriers exist for champions

What's next?

- Learnings from 2019 EDI Strategic Plan foundation for next phase as are activities from the grassroots to leadership
- Strategically aligned with the *University Strategic Plan* and oriented toward *Braiding Past, Present and Future*; further connections drawn from Culture of Care, SEAP, SPRI, Scarborough
- Progressing in tandem and mutually supporting of the People Strategy.

Scope and Objectives

Striving to make equity integral to our working and learning culture by shifting from understanding EDI as "in addition to," to EDI as "what we do"

How do we shape equitable ecosystems that enable all U of A members to flourish collectively? Answering this question is the goal of the integrated action plan for EDI, which will:

- draw from and knit together equity, diversity, inclusion and access commitments across institutional and unit plans, making strategic priorities legible in the process, and
- 2) be responsive in its living implementation to ensure accountability and sustainability.

Benchmarks and measurable outcomes approached with integrity.

Operating Principles

- Centre knowledge holders in discussions and objectives
- Demonstrate commitment to robust accessibility
- Focus on shared accountability by identifying
 - responsibilities (i.e. communications, timelines, deliverables, etc.) held by specific roles and offices, and

Strategic Alignment

• Improve access to Students' Union spaces, resources, and expertise. The Students' Union has a wealth of knowledge, experience, and materials for effective event execution. These assets should be accessible to student groups so that they can host memorable events, develop stronger programming, and create compelling content.

- Differentiate between the responsibilities of the Students' Union and the University. The Students' Union and the University of Alberta, although closely connected, are separate entities that often have competing priorities. The Students' Union should demonstrate its value to students and University partners in all relationships. We should develop resources that differentiate between functions of the Students' Union and University, and clarify responsibilities within existing partnerships.

NEW FIRST PRINCIPLES

Facts

- 1. The University of Alberta lacks sufficient student space to accommodate the current student population
- 1. The landscape of student spaces and the projected enrollment growth on campus will change significantly over the next decade.
 - a. The University plans to grow student enrollment drastically, reaching 60,000 students by 2030.¹
 - b. The University of Alberta has found its per-capita square meter space to be 59% above the U15 average, making it the highest among U15 schools.²
 - c. The University of Alberta's 2021-2022 Space Optimization Strategy (SOS) has targeted a 15% reduction in the institutions physical footprint.³
- 2. Current space planning has not sufficiently anticipated the needs of current or future students.
 - a. Poorly managed spaces have serious implications that impact the quality of student life.
 - b. Student spaces are in need of improvements at a rate that currently outweighs the abilities of the University of Alberta.
- 2. Space planning on campus will impact students' experiences
 - a. Students and student groups require quality spaces on campus to succeed in pursuing their academic and extra-curricular goals.
 - b. Students require space available to them that works with their diverse schedules.
 - c. Some student demographics seek spaces designed intentionally for their communities, such as a dedicated Indigenous gathering space or dedicated prayer spaces, among others. These spaces are often not prioritized by the University.^{4; 5}
- 3. <u>Space planning in new and refurbished buildings will have significant impacts on students.</u>
- 4. Students and student groups alike require quality spaces on campus to succeed in pursuing their academic and extra curricular goals.
- 5. Students require space available to them according to their schedules.
- 3. Students require space that is accessible and that affords the same choices to any user.
 - a. Many spaces on campus are currently inaccessible to students.
 - i. The University often incompletely retrofits inaccessible spaces, resulting in spaces that still do not meet the accessibility needs of all students.⁶
 - 1. Retrofit designs are defined as designs that attempt to address issues of accommodation and accessibility but are temporary or incomplete fixes.⁷
 - ii. There is a lack of awareness of disability on campus.⁸
 - iii. Student-focused public spaces often have significant accessibility barriers. In a nine-factor UASU review of 13 student spaces around North Campus, the average accessibility score in 2023 was 2.2 out of 5, down from 2.9 in 2019.
 - b. Spaces on campus should be developed under principles of universal design
 - i. "Universal design affords any user the same choice while in the built environment." Therefore, spaces no longer need to be built for specific

groups, but spaces are instead designed in a way that any user could access them.⁹

- 4. Several Many spaces at the University of Alberta were built before a change in building codes and thus currently remain physically inaccessible to many students.
 - a. The University is often hesitant and limited in addressing these spaces because the newer, more inclusive code requirements would take effect if these spaces were modified, and therefore many spaces would have to be overhauled completely to meet modern requirements¹⁰
- 5. Although the University has increased investment in gender neutral washrooms¹¹, there are still buildings on campus without accessible gender neutral washrooms¹²
- 6. The University's standard for building cleanliness has recently declined, dropping to level 4 on the APPA scale, which is considered "moderate dinginess."¹³
- 7. Deferred maintenance is defined as an amount needed but not yet expended for repairs, restoration, or rehabilitation of an asset.¹⁴
 - a. Funding for routine building and systems preventive maintenance has been significantly cut back, resulting in a substantial backlog of deferred maintenance.
 - b. The accumulation of significant deferred maintenance liability represents a failure of the government to adequately fund the operations of the University.
 - c. Deferred maintenance reduces the quality of the undergraduate learning experience, the University's public image, and presents a potential health and safety hazard.
 - d. Deferred maintenance issues with access points, walkways and floors, lighting, and many other aspects of the built environment disproportionately affect people with disabilities
 - e. It is inappropriate for the University and the government to expect current and future undergraduates to fund the correction of historically deficient resource allocation.

OLD

- 1. The Students' Union will advocate that the University of Alberta space allocation and development take into consideration the needs of students and student groups both present and future.
 - a. The Students' Union will advocate that student space development match the rate of deterioration.
 - b. The Students' Union will advocate for better care of current student spaces and the upkeep of essential learning environments.
 - c. The Students' Union will advocate that student space development follow the principle of carbon neutrality.

- 2. The Students' Union will advocate for the construction and renovation of classroom space such that they reflect advances in pedagogy.
- 3. The Students' Union will advocate that student spaces are open sufficient hours to address student needs.
- 4. The Students' Union will advocate for spaces that account for the need for universally designed spaces, such that they can be accessed by all students regardless of differences in accessibility needs.
 - a. The Students' Union advocacy on space allocation and building development policies will prioritize buildings that remain most inaccessible to students.
- 5. The Students' Union will advocate for extensive and sufficient consultation with students prior to developing new student spaces on campus.
 - a. The Students' Union will work towards ensuring that students will be responsible for the lowest possible cost for space development, renewal, and maintenance.
- 6. The Students' Union will continue to provide students with space to pursue their academic and extracurricular goals.
 - a. The Students' Union will work towards a better awareness of the current spaces available for students.

Deferred Maintenance OLD

- 1. The University of Alberta Students' Union advocates to the provincial government for one-time, project-specific capital funding packages to the University to remedy the accumulated deferred maintenance liability.
- 2. The University of Alberta Students' Union advocates to the Government of Alberta for the institution of an ongoing, predictable, deferred maintenance funding model to remedy the accumulated deferred maintenance liability.
- 3. The University of Alberta Students' Union advocates for the University to follow construction practices that minimize future maintenance costs, prioritize preventative maintenance in order to identify and remedy potentially serious problems while it is easiest and cheapest, and prioritizes environmental, social, and economic sustainability as well as student well-being and accessibility
- 4. The University of Alberta Students' Union shall advocate to the University to prioritize academic units that are less likely to receive sponsorship money or have been historically underfunded in reference to maintenance costs, and thus have greater need.
- 5. The Student's Union shall advocate to the University of Alberta to prioritize student spaces, spaces used for teaching, learning, and those that directly enhance the student experience, when dealing with deferred maintenance funding. Relevant spaces include but are not limited
 - to
- a. Physical recreation facilities;
- b. Student lounges;
- c. Libraries;
- d. Residences;
- e. Classrooms and lecture halls;
- f. Laboratories/research facilities.

NEW SECOND PRINCIPLES (COMBINED):

- 1. The Students' Union will advocate that the University of Alberta space allocation and development take into consideration the needs of students and student groups both present and future.
 - a. The Students' Union will advocate that student space development repairs match the rate of deterioration;
 - b. The Students' Union will advocate for better care-maintenance of current student spaces and the upkeep of essential learning environments.;
 - c. The Students' Union will advocate for the improval of cleanliness quality on campus, and;
 - d. The Students' Union will advocate that student space development follows the principle of carbon neutrality.
 - e. The Students Union will advocate that the University ensures student spaces to accommodate for student enrollment growth.
- 2. The Students' Union will advocate for the construction and renovation of classroom spaces such that they reflect advances in effective pedagogy.
- 3. The Students' Union will advocate that student spaces are open and available sufficient hours such that they to address student needs.
 - a. In spaces where building hours are reduced to address security concerns, the University of Alberta Students' Union will advocate for student OneCard access outside of standard hours.
- 4. The Students' Union will advocate for spaces that account for the need for universally designed spaces, such that they can be accessed by all students:
 - a. Whilst recognizing that universally designed spaces may not account for all needs, thus further advocacy may be required;
 - b. Whilst avoiding retrofit designs, and;
 - c. Regardless of differences in accessibility needs.
- 5. The Students' Union will advocate for extensive and sufficient consultation with students prior to developing new making changes to student spaces on campus.
 - a. The Students' Union will work towards ensuring that students will be responsible for the lowest possible cost for space development, renewal, and maintenance.
- 6. The Students' Union will continue to provide students with space to pursue their academic and extracurricular goals.
 - a. The Students' Union will work towards a better awareness of the current spaces available for students.
- 7. The University of Alberta Students' Union advocates to the provincial government for one time, project specific capital funding packages to the University to remedy the accumulated deferred maintenance liability.
- 7. The University of Alberta Students' Union will advocate to the University of Alberta for the remediation of the accumulated deferred maintenance liability.
- 8. The University of Alberta Students' Union advocates to the Government of Alberta for the institution of an ongoing, predictable, deferred maintenance funding model to remedy the accumulated deferred maintenance liability.

- 8. The University of Alberta Students' Union will highlight ongoing deferred maintenance liabilities at the University of Alberta to all appropriate levels of government and advocate for adequate institutional funding.
- 9. The University of Alberta Students' Union advocates for the University to follow construction practices that minimize future maintenance costs, prioritize preventative maintenance in order to identify and remedy potentially serious problems while it is easiest and cheapest, and prioritizes environmental, social, and economic sustainability as well as student well-being and accessibility.
- 9. When advocating for development and repairs, the University of Alberta Students' Union will:
 - a. Highlight factors relating to student well-being;
 - b. Work towards a more accessible campus;
 - c. Prioritize social, economic, and environmentally sustainable practices;
 - d. Push for construction practices that minimize future maintenance costs and prioritize preventative maintenance;
 - e. Prioritize spaces with the greatest need, or that would otherwise receive less funding and care, and;
 - i. Spaces that are often not prioritized by the University include but are not limited to dedicated prayer spaces, gender neutral washrooms, Indigenous gathering spaces, Augustana Campus, and Campus Saint-Jean.
 - f. Prioritize cost friendly options, without sacrificing any of the aforementioned principles.
- 10. The University of Alberta Students' Union shall advocate to the University to prioritize continue renovations for academic units that are less likely to receive sponsorship money or have been historically underfunded in reference to maintenance costs, and thus haveing greater need for maintenance and renovations.
- 10. The Student's Union shall advocate to the University of Alberta to prioritize student spaces, spaces used for teaching spaces, learning spaces, and those spaces that directly enhance the student experience, when dealing with deferred maintenance funding. Relevant spaces include but are not limited to:
 - a. Physical recreation facilities;
 - b. Student lounges;
 - c. Libraries;
 - d. Residences;
 - e. Classrooms and lecture halls;
 - f. Laboratories and *+*research facilities.

Below is an overview of the executive committee's activities this past month.

Christian Fotang | President

Augustana Retreat

The Executive Team recently undertook a retreat to the Augustana campus in Camrose to meet with the Augustana Students Association (A.S.A). The visit encompassed a comprehensive campus tour, an informal lunch in the cafeteria, a review of goals and priorities for the academic year with the ASA team, and a crucial meeting with ASA councilors.

The campus tour provided valuable insights into the unique environment of the Augustana campus, allowing us to better understand the facilities and culture-specific to Augustana. Following this, we had lunch with members of the ASA team in the cafeteria. During the goals and priority review session, UASU executives engaged with A.S.A. representatives to review and touch base on objectives for the remainder of the academic year. This collaborative effort aimed to identify shared goals and areas of mutual interest, fostering a spirit of partnership.

A highlight of the retreat was the meeting with ASA councilors, where insightful questions were posed and key advocacy issues were raised. The councilors brought attention to concerns about classroom temperatures, the absence of certificates for Augustana students, and the ongoing need for transit support. These points sparked meaningful discussions and highlighted areas where joint advocacy efforts could be directed.

Moving forward, action items include discussions with the administration around these issues and continued advocacy for improved transit support to municipal and provincial governments.

In conclusion, the UASU Executive Team's retreat to the Augustana campus proved fruitful, strengthening the collaboration between Augustana and the Students Union. The engagement with ASA councilors provided valuable insights and identified key areas for advocacy that will shape the ongoing efforts to enhance the student experience at Augustana.

Strategic Plan Steering Committee

The University of Alberta Students Union (UASU) Strategic Plan Steering Committee has recently initiated its work focusing on enhancing and refining the organization's strategic direction. The committee's efforts thus far have been an initial orientation meeting, which served as a platform to welcome committee members, provide an overview of the work plan, and establish a foundational understanding of the strategic planning process.

During the orientation meeting, the committee delved into the work plan details. This included a comprehensive review of the objectives, milestones, and critical tasks that will guide the committee's activities throughout the strategic planning process. Expectations and roles within the committee were clarified, and following up on the meeting, we are establishing a recurring schedule for meetings and activities. This ensures consistent progress and engagement. Additionally, fosters a collaborative and effective working environment.

As the committee progresses, a key focus will be on reviewing the existing strategic plan of the UASU. This involves thoroughly examining the organization's current goals, objectives, and outcomes to identify areas for improvement and refinement. In preparation for gathering valuable input from various stakeholders, the committee is actively working on drafting questions for surveys and focus groups. This step is crucial for obtaining insights from the diverse perspectives within the UASU community, contributing to developing a well-informed and inclusive strategic plan.

Looking ahead, the Strategic Plan Steering Committee is poised to play a pivotal role in shaping the future direction of the UASU. Through thoughtful review, collaboration, and engagement with stakeholders, the committee aims to create a dynamic and responsive strategic plan that reflects the evolving needs and aspirations of the University of Alberta student body.



Supporting Palestinian and Jewish Students

We've been working with the Dean of Students to support Palestinian and Jewish students directly affected by the ongoing violence. In early October, we ensured the university communicated directly with affected students, providing messages of support and comprehensive information on available resources, ranging from financial to mental, spiritual, and academic support.

To address the specific challenges these students face, we have been focused on assisting folks in seeking leaves of absence, and we are advocating for understanding and flexibility from professors and instructors, especially regarding exam deferrals. Our top priority is the well-being and safety of the students affected.

In our ongoing efforts, I've been in touch with student leaders and members of our Palestinian and Jewish communities to understand their needs better and ensure that our support is tailored to their specific situations. For currently enrolled refugee students, existing means of support were distributed, and I'm committed to pushing the University to enhance the communication about these resources. We shall continue to actively engaginwith the Dean of Students, University administrators, the International Students' Union, and various student groups to address concerns and ensure the safety and rights of all students.

CAUS Advocacy Week

Last week, I joined Chris and many of our counterparts from across the province in lobbying the provincial government and MLAs to support CAUS' post-secondary education. I met with Ministers: Yaseen, and Glubish, and MLAs, Hoyle and De Jonge. Throughout these meetings, I and my colleagues stressed the importance of the measures the government take to address the ongoing cost of living crisis that students are experiencing. This including the need to better fund grants through the expansion of the new beginnings scholarship, re-launching summer jobs programs and improve needs of international students through better PR application programs.

GFC APC/FDC

At a joint academic planning and Facilities and Devemlopments Committees we discussed the university's Integrated Asset Management Strategy (IAMS). IAMS was approved by the General Faculties Council and the Board of Governors in June 2019. The strategy ensures that decisions related to the stewardship of its infrastructure across the five campuses are made holistically and with the university's long-term objectives in mind. In this meeting I highlighted the importance of ensuring building accessibility and asked how the IAMS will equip the University to improve accessibility as a top priority.

Syllabus Management Tool

The University of Alberta is looking into implementing a Syllabus Management Tool for instructors. This tool would involve the integration of existing University of Alberta systems and adaptation to the particular needs of individual departments and faculties. The implementation of this tool can significantly streamline syllabus creation for instructors and can help students by making communication of syllabi easier and more robust for students. It is also important to note that implementation of this tool can be contentious for some instructors, as they may have some concerns with centralization of processes that were previously not centralized, among other considerations.

In addition, this tool is something that I believe is the result of multiple years of advocacy from the UASU for the need of a syllabus bank for students. In order to further support this initiative, over the past month I presented to the Academic Affairs Committee of the Association of Academic Staff of the University of Alberta (AASUA) on how this Syllabus Management Tool can benefit students. I believe the current plan is for some faculties to be onboarded by July 2024 for Fall 2024 syllabi, and other faculties being onboarded over the following two years!

Lecture Capture Advocacy

A large academic priority this year has been advocating for increased academic accessibility and flexibility for students through lecture capture. This has taken the form of advocating directly to the Provost and Vice-President (Academic), the Deputy Provosts and different Vice-Provosts of the University of Alberta around the specific actions that can be taken to facilitate instructors' move toward lecture capture, when possible. Currently, in the works is setting up for each Faculty Council meeting of different faculties to have a discussion item about instructors' barriers or concerns with lecture capture, in order to hopefully collect feedback to conduct a larger survey that can capture the perspectives of instructors at the University of Alberta. Alongside this initiative, conversations are being had about the investment into classroom technology and ensuring that more instructors that want to provide lecture capture to students, have the necessary equipment to offer it!

EDI Steering Committee

The University of Alberta's EDI Steering Committee has begun to reach out to different groups in order to conduct consultation in preparation for creating an EDI Integrated Action Plan for the University of Alberta. Carrie Smith, the Vice-Provost (Equity, Diversity



and Inclusion), will hopefully be joining SU's Students' Council on Tuesday, November 21st to hear from UASU council members about their perspectives on EDI at the University of Alberta. This can be a great opportunity to offer feedback on what each of you identifies as EDI priority areas for the University of Alberta to address over the next few years. The work for this committee has currently been focused on setting up avenues through which student consultation can occur. The current plan is for consultation at SU's Students' Council, consultation with the Student Representative Associations (SRAs), potential tabling and a survey on UASU Perks to help capture the perspectives of as many different students as possible. In addition, the EDI Steering Committee has planned several other groups to speak with, from across the University of Alberta!

Syllabus Management Tool

The University of Alberta is looking into updating its learning management system (LMS). This is a part of the LMS of the Future Project. A learning management system is the name for the software through which different platforms like eClass are run. Currently, the University of Alberta uses an open-source LMS called Moodle, but the LMS of the Future Project is looking at moving toward a vendor-supported LMS. As I understand it, moving toward a vendor-supported LMS can allow for different advantages such as simplifying software management, reducing operational requirements and enhancing flexibility. However, it is also important to note that this move is a bit contentious, as different instructors have concerns about what this move means for the work they have done with Moodle. The current plan is for the early adopters to be onboarded and trained to use the new LMS by Fall 2024 and the majority of University of Alberta classes to move to using a new LMS by Fall 2025. The UASU VPA currently sits in the LMS of the Future Advisory Committee.

On November 2nd I had the pleasure of attending the Edmonton Metro Region's Housing Symposium followed by Forward/Slash YEG. The symposium was great to connect with Edmonton City Council Members as well as key stakeholders in municipal politics. I was able to chat with several City Councillors to thank them for their support in passing the recent changes to Edmonton's Zoning Bylaw.

In the evening, myself and the rest of the executive team were able to attend Forward/Slash YEG, an event meant to celebrate Edmonton's Business community. While attending I was able to engage with 8 different MLAs from both government and



opposition, laying the groundwork for CAUS's record-breaking advocacy week. Moreover I was able to chat with several more members of Edmonton City Council as well as some staff from the Mayor's office. As always, this work helps grow the profile of the University of Alberta Students' Union as a cornerstone of Edmonton's diverse and thriving business community.

The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwacîswâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsítapi (Blackfoot), Métis, Dënesųłiné (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?
