Dear Council,

Well, we are in interesting times. The past year has been a challenging one, and placing student needs at the forefront is still important as ever.

Here's part of a recent Edmonton Journal article I was quoted in:

## Students hit especially hard

"Joel Agarwal, president of the University of Alberta Students' Union, said in an email the pandemic continues to create challenges for students who struggle with high tuition. He said the students' union surveyed more than 5,000 students just before the pandemic hit in March and found most were working while studying, while nearly 40 per cent were working in a job unrelated to their field of study.

Most of these jobs were in the service sector.

"It's a perfect storm of problems that hit students especially hard," Agarwal said. "When students can't work, they can't shoulder those costs, so mental health concerns are rising. Since Alberta's student aid system has the worst grants-to-loans imbalance in Canada, students rely heavily on whatever work they can find."

Tuition is set to increase 7% this March at the Board of Governors, and I intend to push back while including students in the process. The plan is to present the case as to how tuition increases are negatively impacting students, and putting out a survey to collect stories to present at the board. If you are interested, or have any ideas / suggestions - please reach out to me.

As I noted in a recent tweet: "I am very concerned. Deregulated tuition is a bad idea - it fundamentally drives inequity. By 2023, #abpse tuition & fees will be 450% higher than in 1990 and among the highest in Canada. Without regulation, how much worse off will we be by 2030?" I am deeply concerned about a <u>sector level board as well as deregulated tuition</u> which would have many large scale implications for students. VP Ley and I are working hard with the Council of Alberta University Students to plan a province wide campaign to promote the importance of Post Secondary Education (PSE) later this semester. In the meantime we



are participating, along with every CAUS school in an online campaign which you can participate in <a href="here">here</a>.

This semester, I continue to chair the Governance Restructuring Task Force (GRTF), where we are working towards improving the effectiveness of our governance structures, while tackling some of the cultural issues brought up in past years. The GRTF will be providing a report to Council in the coming weeks.

#### Howdy Council!

I hope the first month of the semester has gone well for you! I find the winter semester always seems to go by much faster than the fall. Anyways, i've been up to quite a bit since my last report, so check out below if you're curious.

#### **Priority Vaccination for Health Sciences Students**

Over the past couple of months I have been working with the Nursing Undergraduate Association and Councilor Filpovic to resolve some issues around safety on practica for nursing students. Although we have reached a solution the systemic risk is still present. Due to this concern about student safety I have decided to expand the scope of our advocacy on this issue. Last monday i presented at the Council of Alberta University Students and made the case for why they should be advocating provincially for priority vaccination for health sciences students. That presentation went quite well and now CAUS is working with the same organization who successfully achieved priority vaccinations for paramedics. Hopefully this advocacy will bear fruit.

#### Students on Experiential Learning Policy Creation Process

Myself and VP Kidd have been hard at work on the drafting of a new UAPPOL policy. The working title for this policy is the "Students on Experiential Learning Policy." This policy aims to address some egregious gaps in UAPPOL. Currently their protections and guidelines for students on practica are disappointingly sparse, due to this we have worked to draft a policy to provide the institutional responsibility to protect these students. This policy drafting process is still in the early consultation phase. To date we have done consultation with the Director of the Sexual Assault Center, The Director of Student Conduct, The Dean of Students, a Vice Dean of Students, the Registrar and two Associate Registrars, The Vice Provost Programs, the Provost's office Issues Manager, and the Vice Provost Learning Initiatives. Currently there are plans to bring this policy draft to the Council of Faculty Associations' Members Services Board. We are hoping to have this policy enacted by April 2021.

#### **Open Education Policy**

Councilor Fotang, Councilor Batycki, and myself have been hard at work on the Second principles of the Open Education Policy! The second principles passed unanimously at Policy Committee and I am looking forward to passing them at council! I believe this will be the first new policy of the year, and possibly longer! This policy represents a topic that has been vital to the role of the VP-A for since prior to when I began my degree, although there has not been a formal policy guiding it. This policy seeks to guide advocacy and provide information on topics such as Open Data, Open Research, and the ever popular Open Educational Resources.

The Application for the final two GFC representative seats is currently live! Applications will close thursday the 28th, interviews will take place between February 1st -4th and individuals should be on the agenda for ratification by council at the February 9th meeting. Currently we already have multiple applications for the seats. Which means we are now only steps away from having every student seat on GFC filled for the first time in ever (in my, or the GFC secretary's knowledge). To put that in context we will have DOUBLED the student presence from the 2019/2020 academic year and set a new record that can only be beaten if the provincial government changes the PSLA to add additional student representatives to the General Faculties Council. I look forward to celebrating once this process has run its course.

#### Online learning

The General Faculties Council will be discussing the topic of online learning at their January 25th meeting. This has been an issue I have been raising ad nauseum within my term. I have pushed for a more fulsome discussion to take place at GFC, however due to the exclusive focus on academic restructuring, that has not been able to happen until now. I am looking forward to this discussion and I plan on pushing quite extensively on the various issues that have been brought to my attention over this year. Fundamentally the lack of action on the concerns i have raised over the last eight months is a disservice to the student body at this university.

#### Assessments during reading week

Multiple students have reached out to me about scheduled assessments during the Winter 2021 reading week. I've been raising these concerns to various Vice Provosts to ensure that students actually have a reading week as has been scheduled in the calendar. The current wording for the university calendar as that "classes are fully withdrawn" for reading week. The opinion of the Vice Provost Learning Initiatives is that this statement means courses are fully on pause and that week is treated like individuals are not enrolled in courses. I am pushing for there to be a communication to professors that they are prohibited from scheduling assessments during this break.

#### Minimum technology requirements for professors

Back in the summer I had worked with the university on the drafting of minimum technology requirements for students taking part in an online semester. It was an interesting process working to balance both access and ensuing students had the tools they needed to thrive. Over the course of the fall semester and since returning to courses for winter 2021, it has become clear that the lack of similar requirements for the professoriate has been harming students. Many professors may not meet the technological requirements for the courses they are teaching. Due to this I have been raising the topic of minimum technological requirements for professors teaching remote delivery courses. Hopefully some of these issues are resolved soon.

# **Business Update**

## **Temporary Closure of Dewey's**

We have made the difficult decision to close Dewey's for the Winter semester. Dewey's has always served as a central social gathering place on North campus, so naturally this wasn't an easy decision to make. But it was straightforward in the sense that student safety is always our number one priority. Our staff have been doing a fantastic job at keeping our spaces clean and sanitary, and for that I would really like to thank them.

The primary problem is that we don't have the ability to ensure that guests at Dewey's are in the same household or bubble. Since public health orders are clear that indoor social gatherings between multiple households aren't safe, we just want to do our part in keeping students safe.

Opening and closing a restaurant takes a fair bit of effort and resources, and we cannot foresee what COVID case numbers and restrictions will look like in the upcoming months. The plan is to keep Dewey's closed for the Winter semester, but we are always open to student feedback on our decisions. Essentially, serving students while prioritizing their safety is our goal.

#### Hello Council!

I hope you are all doing well and enjoying your new classes. I am taking the History of China-Western Relations, which so far is a pretty fascinating course and I am looking forward to the rest of the semester. Of course, online delivery does suck-- I hope you are holding up well and suffering from less zoom fatigue than me.

#### **Superboards? Megaboards?**

Part of the Alberta 2030 review is looking at how governance works in universities. Right now, we have three governing bodies-- GFC (for academic decisions), the Senate (for community relations), and the Board of Governors (for business decisions). The 2030 review is considering making changes to that model and creating Alberta-wide "superboards". These boards could take a few forms. One is a pretty basic coordinating function where they help work out transfers across institutions and organize back-end services like IT and finance so that universities can share them, saving money. This already exists in a lot of US states and would be no problem.

If they go for a more dramatic change where a lot of power gets taken away from our Boards and put in a superboard, U of A could lose control of decisions around tuition, buildings, program offerings, that kind of thing. I call this option a "megaboard". I know we don't always get along with our Board, but there's no situation so bad you can't make it worse. I have trouble seeing how student feedback would be meaningfully included on a board that had to represent 140,000 students across 4-6 institutions. It could also give the government a much more direct line to impose their vision on universities-- sometimes that might be a good thing, but often it would not be. CBC ran an article about this recently and I had some quotes. Check it out here!

#### Modest Progress on Campus Sexual Violence

Government can be incredibly slow at the best of times, and this is not the best of times. Still, things are grinding along slowly-- I have been badgering them and the department has promised us an update in early February. Stay tuned.

#### Alberta Budget

We are pretty sure the Alberta budget is going to drop on February 25th. This could really be a disaster for U of A-- we expect a cut, but this year is obviously not going as planned for the government. That could either mean they choose to give supports to

universities to help them get through COVID, like most other provinces have, or they could make a huge cut because of the larger deficit. I would like to see the first option and I think it would be the economically wiser option as well as just being good for students, but unfortunately there is a good chance we get option 2. So brace yourselves, things could be about to get crazy (as if they weren't already).

#### **Penguins and Protests**

I always try to solve problems in a collaborative and friendly way, and I have really tried to use that philosophy working with government. Unfortunately, we just have not been getting the results we need. Our traditional lobbying methods have been getting limited results, and we can't run normal protests, so we need to think outside the box to fulfil our mandate. Me and the CAUS team, along with UASU marketing, are working on a series of ideas which I hope to be able to announce pretty soon-- I just want to make sure we get them planned properly first. However, we are starting small and doing one "protest" this week, a snowman protest Thursday at the Legislature!



This was VP Draper's idea and frankly is pretty cool. We can get a bunch of snow

penguin molds for about 3 dollars each at Dollarama, and we are going to be using teams to make a giant snowman protest at the Legislature. There are going to be tiny protest signs for the snowmen to hold. They are biodegradable, but we will come clean them up after a couple days just to be safe. Let me know if you want any more details. Dear Council,

#### **College Deans**

- 1. College Deans Announcement: available on the Quad, the President's Office put forward an update. After 18 months, the president will review the College Dean positions and report to BoG and GFC. The board will develop metrics for college performance which colleges will use and report monthly to the board for 12 months.
  - a. Interim College Dean of the College of Health Sciences is Greta Cummings, Interim College Dean of the College of Natural and Applied Sciences is Matina Kalcounis-Rueppell and Interim College Dean of Social Sciences and Humanities is Joseph Doucet.
  - b. Over the next 6 months these College Deans will develop a strategic plan for interdisciplinary teaching and research and a model for shared administrative services. New colleges will be in place by July 1, 2021. New acting Deans will be implemented by July 1, 2021 for faculties of Nursing, Science and the Alberta School of Business, which gave up Deans to the College Dean position.

#### 2. January 8, 2021 Chairs' Rebuttal

- UAlberta department and faculty chairs felt Bill made mistakes during the
  December 11th board meeting and emailed Faculty Deans and board members.
  One issue they had was the board developing metrics for college performance
  when the board is not a group of academic specialists.
- b. To reestablish trust, they have asked for three things from the president:
  - i. Explain to the January 25th GFC meeting about not supporting GFC's recommendation.
  - ii. Allow GFC to evaluate and approve the scope and mandate of colleges and College Deans and come to consensus on the correct path forward.
  - iii. Ensure that board metrics are discussed and ratified by GFC.

#### **Projects**

1. French Resources in DoS: I reached out to Steve Dew about AUFSJ's lack of French resources on the Dean of Students' website and access to French-speaking staff in student services. Awaiting a response.

## Proposed 2021 Question

The U-Pass program provides universal transit access across Edmonton and six surrounding municipalities at a significantly reduced rate, providing more affordable transportation access to students and encouraging the use of public transit. The current U-Pass deal expires in August of 2021, and so a referendum is being held to renew the U-Pass program.

The U-Pass will cost University of Alberta undergraduate students \$180 per semester for the years 2021-2025. The negotiated agreement will see no fee increase for the entire 4-year contract. The University of Alberta will no longer be subsidizing the U-Pass cost.

Generally, students cannot opt out of this fee: all full-time and part-time undergraduate students participate in the U-Pass program and pay the full fee, with the exception of Augustana students and students whose course locations are designated as online, as defined by the Registrar's Office. Under certain circumstances, some undergraduate students will be exempt or eligible to opt out of the U-Pass program. New eligibility for opting out under this contract includes:

- Students who receive Assured Income for the Severely Handicapped (AISH)
- Students who are over the age of 65
- Students whose primary residence is an exceptional distance outside of the regional transit service areas

#### Bylaw 1100 - A Bylaw Respecting the Executive Committee

# 1 Composition

- 1. The Executive Committee consists of
  - a. the President;
  - b. the Vice President (External);
  - c. the Vice President (Academic),
  - d. the Vice President (Operations and Finance);
  - e. the Vice President (Student Life); and
  - f. the General Manager, as a non-voting member.

#### 2 Mandate

- 1. The Executive Committee shall
  - a. manage those aspects of the Students' Union not otherwise provided for in legislation; and
  - b. represent the Students' Union to all external parties.
- 2. The Executive Committee
  - a. has the authority to direct any of its members; and
  - b. may delegate any of its authority.

# 3 Conduct of Meetings

- 1. The President is the chair of the Executive Committee.
- 2. Quorum of the Executive Committee is four voting members.
- 3. The Executive Committee has the same reporting requirements as a standing committee of Students' Council.

#### 4 Members

- 1. The President
  - a. shall develop and maintain awareness of significant issues that impact students;
  - b. is the primary spokesperson for the Students' Union;

- c. shall supervise the affairs of the Students' Union subject to the authority of the Executive Committee and Students' Council; and
- d. has the authority to direct the General Manager.

#### 2. The Vice President (External)

- a. shall develop and maintain awareness of significant issues external to the University of Alberta that impact students;
- b. shall advocate for the Students' Union to the federal, provincial, and municipal governments; and
- c. shall lead and coordinate the Students' Union's efforts on advocacy external to the University of Alberta.
- d. Shall lead and coordinate the Students' Union's efforts on fundraising.

#### 3. The Vice President (Academic)

- a. shall develop and maintain awareness of significant academic issues that impact students;
- b. shall advocate on behalf of the Students' Union on academic issues; and
- c. shall lead and coordinate the Students' Union's efforts on academic advocacy
- d. Shall oversee and critically examine the governance structure and supports at the Students' Union and
- e. Shall provide support to the student members of the General Faculties Council as well as work to ensure student seats are filled on GFC.

#### 4. The Vice President (Operations and Finance)

- a. shall develop and maintain awareness of the Students' Union's operations and finances;
- b. shall oversee those portions of the Students' Union's budget process falling within the realm of the Executive Committee;
- c. shall provide operational and financial advice to the Executive Committee and its members; and
- d. shall, in the absence of the President,
  - i. chair the Executive Committee, and
  - ii. have the authority to direct the General Manager.

#### 5. The Vice President (Student Life)

a. shall develop and maintain awareness of significant non-academic issues internal to the University of Alberta that impact students;

- b. shall advocate on behalf of the Students' Union on non-academic issues internal to the University of Alberta; and
- c. shall lead and coordinate the Students' Union's efforts on advocacy on nonacademic issues internal to the University of Alberta.
- 6. The General Manager
  - a. shall provide support to the Executive Committee and its members;
  - b. shall implement the directives of the Executive Committee; and
  - c. shall oversee and direct those portions of the Students' Union staff who report, directly or indirectly, to them;
  - d. shall provide a semesterly report to council about their work

## 5 Term of Office

- 1. The President and the Vice Presidents of the Students' Union must be members of the Students' Union.
- 2. The President and the Vice Presidents of the Students' Union shall be elected to serve a term lasting from May 1 to April 30 of the following year.
- The General Manager shall be selected in a manner prescribed by the Executive Committee and shall serve at the pleasure of the Executive Committee, and ratified by Council.

Student Representative Association running Faculty Association Membership Fee (FAMF) referendums this upcoming election have raised concern due to the remote nature of campus life this year the 15% voter turnout required for the implementation of fees (Bylaw 8200;s7,ss5b) might be unattainable. After much discussion in committee and consultation with council, the committee proposes an amendment to Bylaw 8200:s7 to create another subsection stating that:

Until September 1<sup>st</sup> 2021, the minimum voter turnout necessary for the creation or renewal of a Student Representative Association fee shall be 10%. This date may be extended by a simple majority vote of Students' Council if it is deemed to be appropriate.

#### Abstract

The Engineering Students' Society (ESS) is the student faculty association for the Faculty of Engineering. As an undergraduate engineering student, you are currently charged a Faculty Association Membership Fee (FAMF) of \$10.00 per semester. The proposed renewal of the membership fee of \$10.00 per student, per semester will provide engineering student groups with access to funding.

The membership fee will also help fund events and initiatives such as the ESS Career Fair, GEER Week, mental health workshops, and professional development workshops. Additionally, the membership fee funds student group activities such as vehicle project groups, engineering related advocacy groups, and philanthropic initiatives.

The conditions of the fee shall include:

- 1. It shall be distributed according to the framework approved by the University of Alberta Students' Union Students' Council and is subject to the oversight of the Audit Committee.
- 2. Part-time students will not be charged the membership fee.
- 3. Students who are not on campus (on a co-op term or study term abroad) will not be charged the membership fee.
- 4. The fee shall not be charged in the Spring/Summer semester.
- 5. Students may optout of this fee by contacting the ESS before the add/drop deadline of each semester.
- 6. The fee will have a three (3) year lifetime with an expiry of August 31, 2024.

# **Summary**

The Faculty Association Membership Fee (FAMF) is used to fund on-campus and online (engineering) initiatives such as:

- Discipline clubs
- Engineering student groups
- Engineering student activities, conferences, seminars
- University of Alberta Engineering Competition
- Health and wellness initiatives
- Professional development events and services
- GEER Week

Much of this funding is vital to the above mentioned groups and activities and will allow for the long term continuance of on-campus initiatives.



# **Preamble**

#### Data Collection

The data and feedback in this report was collected in two primary methods:

- 1. Discipline club feedback, collected by one-on-one consultation in August, 2020.
- 2. Direct student feedback, through a redcap survey.

#### **Purpose**

As the Engineering Students' Society, and the Faculty Association for engineering, our mission is to promote professional awareness among engineering students by encouraging a sense of unity and integrity through the combined efforts of all engineers working together in both social and technical activities. The Faculty Association Membership Fee (FAMF) allows the Engineering Students' Society (ESS) to offer a wide range of events and services that aim to fulfil this mission.

#### Amount

Each full-time and on-campus student in the Faculty of Engineering shall be required to pay \$10.00 per term as a FAMF. Part-time students and off-campus students pay \$0.00 per term. Visiting and Special students as defined by the University of Alberta are exempt from payment under the Bylaws.

## Scope

The scope of this proposal is to renew the engineering FAMF. The FAMF was originally created and implemented for the 2002-2003 year with a four year term. It was then recreated for the 2006-2007 year with an expiry in August 2010. It was once again recreated in the 2010-2011 year for another four year term expiring August 31, 2015. FAMF was not collected in the 2014-2015 year and was renewed in Winter of 2015 at \$7.00 per student for a three year term ending August 31, 2019. A campaign for a \$20.00 per student FAMF was proposed in 2018, and failed to pass a referendum of engineering students. Most recently, a \$10.00 per student FAMF was created in 2018 for a two-year period, and expires on August 31, 2021. The intent is to replace the current FAMF with a new FAMF model for a three year period beginning Fall Term 2021.



## Fee Lifetime

The engineering FAMF will be collected starting Fall Term 2021 and will be collected until Winter Term 2024, inclusive. The expiry will occur on August 31, 2024. The three year term was decided upon based on the ever-changing needs of the engineering students, and the clubs for which many are a part of.

## Opt-Out Mechanism

The ESS will be responsible for administering the opt-out mechanism for the FAMF. Engineering students must provide written notification of their intent to opt-out of the FAMF during the term that they have paid. The ESS shall release reimbursements within one month of receiving the funds from the Registrar's Office (via the Students' Union). See *Appendix III: Reimbursement Form* for the full Reimbursement Form.



#### Allocation

The proposed allocation of the Engineering Students' Society FAMF is as follows:

<sup>\*</sup>Half (15%) of the allocated funds for discipline clubs will be distributed on a per capita basis and the remaining half (15%) will be distributed equally.



## Financial Oversight

The ESS will require proposals from the recipients of the FAMF monies who are not the ESS or Discipline Clubs. These proposals will outline the anticipated expenditures to be made with the allocated funds, further requirements for the proposals are dictated by the ESS Policy Manual. These proposals will be evaluated and approved by the Engineering Students' Society's Undergraduate Funding Committee as per the ESS Policy Manual sections B.2.4, C.2.2, C.2.3 and C.2.4, which can be found in *Appendix I: ESS Policy*. The ESS will also require annual reports indicating how funds received have been spent from each of the recipients (excluding the ESS). The Board of Directors of the ESS is delegated the authority to require each of the recipients to provide the Board a satisfactory accounting of their spending of the fee money and may withhold allocated funds if no such accounting is provided. Additionally, the annual budget of the society, which accounts for the use of FAMF monies, must be ratified by the Board of Directors as per the ESS Policy Manual section B.2.1. The ESS will be accountable to the Students' Council with respect to financial oversight as required by Students' Union Bylaw 8200.



## What Does FAMF Provide For?

## Discipline Clubs

Oftentimes, discipline clubs are the first point of contact for students and are a provider of many services and events to their respective student populations. Funding will be increased due to the ongoing pandemic and due to the student demand. Many discipline clubs are facing a loss in sponsorship and revenue from lack of student run events. The following are a list of some of the services and events provided by discipline clubs:

- Popsicle Stick Bridge Competition (Civil and Environmental Students' Society)
- Merchandise Sales (Various clubs)
- Hackathons (Computer Engineering Club)
- Technical and Guest Speaker Events (Various discipline clubs)

The proposed model of distributing half of the allocation on a per capita basis, and distributing half of the allocation equally, is due to the disparity in revenue and sponsorship potential. While larger discipline clubs provide services to a larger demographic of students, these clubs also receive a significantly larger portion of funding from merchandise sales, ticket sales, and industry sponsorship. The proposed model allows for smaller discipline clubs to receive enough funding for operations and growth, while still allocating more funds to clubs with larger memberships.

# Engineering Student Group Fund (ESGF)

Similar to the discipline clubs allocation, the ESGF will provide funding to non-discipline club engineering student groups. Engineering student groups contribute to student life and are a major part in building the engineering community at the university. Policy regarding the ESAF can be found in the ESS Policy Manual section C.2.3.

# Engineering Student Activities Fund (ESAF)

ESAF is purposed to help engineering students attend seminars, conferences or sessions related to their engineering education. These activities help enrich the educational experience and also allow for networking opportunities for students. Policy regarding the ESAF can be found in the ESS Policy Manual section C.2.2.



#### GEER Week

Dating back to 1942, GEER Week has been a staple in engineering life at the university for generations. The events within GEER Week provide students with relief from academics, through the opportunity to participate in activities unrelated to their degree.

#### Health and Wellness

Funding for health and wellness will provide for workshops, training, and wellness activities. University students are at an elevated risk of negative mental health outcomes relative to the general population, with the risk for engineering students being especially acute. The high incidence of negative mental health outcomes is a result of increased stress. Health and wellness initiatives allow for engineering students to destress and maintain a healthy and active lifestyle, while also being informed on supporting others in distress. Allocation for health and wellness will be increased from the last FAMF due to higher precedent during COVID-19 and remote delivery. The following are a list of some of the services and events provided by health and wellness initiatives:

- Mental health workshops and training
- Online workouts challenges
- Take a break events

# Engineering Public Good Fund (EPGF)

EPGF is purposed to help improve the quality of life of engineering students. The EPGF allows any student to pursue a project which is to improve the day to day experience of all undergraduate engineering students. Policy regarding the EPGF can be found in the <u>ESS Policy Manual</u> section C.2.4.

# Professional Development

Funding for professional development initiatives will provide members with career building skills and professional awareness. These activities help enrich the academic experience and prepare students for their careers after graduation. The following are a list of some of the services and events provided by professional development initiatives:

- ESS Public Speaking Program
- Excel and VBA workshops
- Other software workshops
- ESS Career Fair



# Conferences and Competitions

Funding for conferences and competitions will mainly provide for hosting the University of Alberta Engineering Competition (UAEC). Surplus funds are used to subsidize the cost of sending student delegates to conferences, as well as regional and national engineering competitions.

# Engineering Carnival

The Engineering Carnival is a traditional event held by the ESS to welcome students to campus and expose them to a variety of opportunities in our community. The event allows Engineering Student Groups to do outreach and recruitment to prospective members and the university community. Additionally, philanthropic elements such as charity dunk tanks are integrated into the event in an effort to give back to the community.



## **Consultation and Feedback**

The data and feedback in this report was collected in two primary methods:

- 1. Discipline club feedback
- 2. Direct student feedback

## Discipline Club Consultation

Discipline clubs were invited to a consultation meeting regarding the 2020/21 FAMF proposal. Consultation with discipline clubs was done as the discipline clubs are members of the ESS Board of Directors and are the closest connection to undergraduate engineering students. Out of 9 discipline clubs, 5 attended the consultation meetings. The following is a summary of the feedback received.

- 1. 100% of discipline clubs generated revenue from merchandise sales, while 80% of clubs generated revenue from ticket sales and food sales. For the current year, all discipline clubs planned to generate revenue from merchandise sales and zero discipline clubs expected to receive revenue from food sales. 40% of discipline clubs still planned to generate revenue from ticket sales.
- 2. 40% of clubs regularly receive funding from grant applications and ESS funding, and 60% receive funding from sponsorship and faculty funding. In the current year, 100% planned to seek funding from sponsorship, 80% planned to seek funding from the ESS and the faculty, and only 40% planned to seek funding from grants.
- 3. 100% of discipline clubs were aware of FAMF and the amount of funding received from FAMF.
- 4. 100% of discipline clubs were in support of accessing additional funding from the Engineering Student Group Fund due to the current pandemic.
- 5. 60% of discipline clubs were in favour of the discipline clubs receiving the largest allocation of funding.
- 6. 80% of discipline clubs were in favour of a distribution model in which discipline clubs received a flat percentage of funds, and the remainder being distributed on a per capita basis.

#### Suggestions from Discipline Clubs:

- "Either the ESS needs to provide students more direct support, or discipline clubs need to receive more support in funding to provide for their students"
- "Discipline clubs could distribute funds to project groups if the ESS funds were replaced with a larger allocation for discipline clubs"
- "Mental health services need more funding; dogs are great but that doesn't really cut it."



From the consultation process, it was clear that discipline clubs would receive a large reduction in funding due to the ongoing pandemic. Furthermore, it was clear that before this reduction, discipline clubs could use more support in terms of funding. In response, the ESS has increased the discipline club allocation significantly. Additionally, most clubs were in favour of a distribution model that provided a flat rate, as well as a per capita rate and this model has been implemented in the proposal. Finally, the suggestion of an increase to funding for health and wellness has been implemented.

## Student Survey

A <u>survey</u> was sent to students via *EnggLink*, the engineering student newsletter, as well as was shared on the ESS Instagram and Facebook pages. Included with the survey was a brief video explaining FAMF which can be found <u>here</u>. 185 students completed the survey, of which 20 were first year students and the remaining 165 were upper year students. The survey first asked the participants to indicate which year of study they were in and if the student indicated that they were in their first year of study, they were prompted with one question that pertained to the online services provided to first year students this year. If the student indicated that they were in their second year of study or higher, they were prompted with a survey that pertained to engineering activities that were held on-campus in the past.

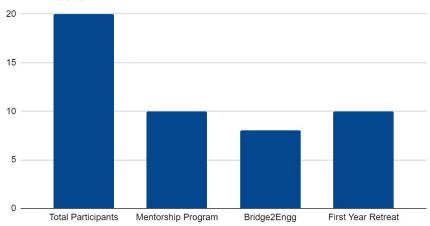
A breakdown of the survey follows, as well as key takeaways and their impacts on the FAMF proposal. Additionally, tabulated results can be found in *Appendix II: Survey Results*.



### **First Year Student Question**

1. While events have been provided online in the current academic year, incoming students were still inclined to participate. Additionally, it was found that the ESS Mentorship Program and First Year Retreat were both utilized by 50% of survey participants, while the Faculty of Engineering Bridge2Engg program was only utilized by 40% of survey participants.

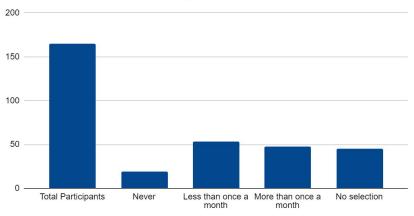
Have you participated in any of the following initiatives? Check all that apply.



### **Upper Year Student Questions**

2. It was found that only 15.8% of upper year participants stated they had never participated in community events, while 40% participated in community events more than once a month. 44.2% of participants indicated that they participated in events less than once a month. 27.3% of participants did not select an answer, and the percentages were calculated based on a total of 120 responses.

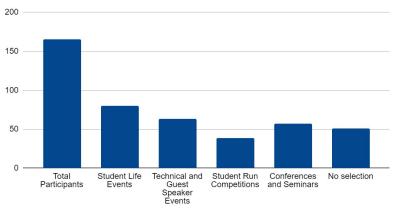
Prior to the COVID-19 pandemic, how often did you participate in events held on engineering campus?





3. 70.2% of upper year participants have attended Student Life Events, 55.3% have attended Technical and Guest Speaker Events, 50% have attended Conferences and Seminars and 34.2% have attended Student Run Competitions. This indicates that a majority of participants attend social events and technical/guest speaker events. There is a significant demand for conferences and seminars, and a much smaller demand for student run competitions. 30.9% of participants did not select an

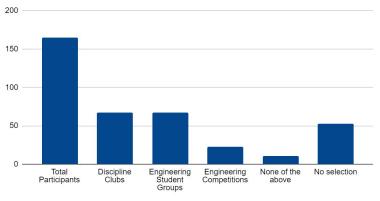
Prior to the COVID-19 pandemic, have you attended any of the following events held on engineering campus? Check all that may apply.



answer, and the percentages were calculated based on a total of 114 responses. As there was no option for "None of the above", it is assumed that 30.9% of participants do not attend student events. Roughly half of this population can be assumed to be the individuals that indicated they have never attended community events and the other half may attend events held by faculty or external groups.

4. It was found that 59.8% of upper year participants are involved with both Discipline Clubs and Engineering Student Groups, while only 20.5% of students are involved in Engineering Competitions. 9.8% of students indicated that they are not involved in any of the listed opportunities. 32.1% of participants did not select an answer, and the percentages were calculated based on a total of 112 responses. As there was an option for "None of the above",

Have you been involved with the following volunteer opportunities in engineering? Check all that may apply.

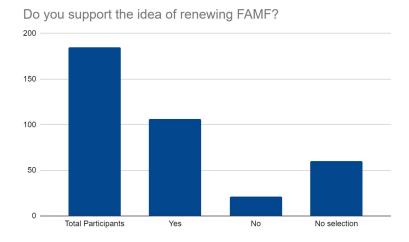


this is likely attributed to human error. However, if it is assumed that these participants do not volunteer with student groups or participate in competitions, only 38.8% of participants are not involved in extracurricular activities.



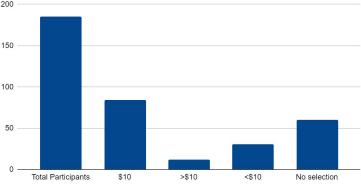
### **All Participants Questions**

5. It was found that 83.5% of participants support the idea of renewing FAMF. 32.4% of participants did not select an answer, and the percentage was calculated based on a total of 127 responses.



6. It was found that only 24.4% of participants believed that FAMF should be less than \$10 per term per student. 32.4% of participants did not select an answer, and the percentage was calculated based on a total of 127 responses.

How much do you think engineering undergraduate students should pay per on campus semester?





The key takeaways from the survey are as follows:

- 1. Every event, service or initiative surveyed on, was utilized by a minimum of 50% of survey participants, with the exception of engineering competitions. This includes first year students who have had less access and welcome to the community due to the COVID-19 pandemic.
- 2. 40% of upper year students participated in events more than once per month, and another 44.1% of upper year students participated in events less than once per month.
- 3. At least 61.2% of upper year survey participants are involved in extracurricular activities outside of their studies.
- 4. Both Discipline Clubs and Engineering Student Groups engage 59.8% of upper year participants involved
- 5. 83.5% of survey participants support the idea of renewing FAMF and only 24.4% of participants believed FAMF should be less than \$10 per term per student

The impacts on the current FAMF proposal are as follows:

- 1. Due to the large demand for the community initiatives that are funded by FAMF, the large number of students who participate in extracurriculars and the overwhelming support of a renewal, the ESS is submitting this proposal to renew FAMF for a three year period.
- 2. Due to the overwhelming support of FAMF being at least \$10 per student per term, the current proposal will keep FAMF at \$10 per student per term.
- 3. Due to the engagement for Discipline Clubs and Engineering Student Groups, as well as the demand for social and technical events, a majority of the FAMF allocations are assigned to Discipline Clubs (30%), the Engineering Student Group Fund (20%), and the Engineering Carnival (2%).
- 4. Due to the demand for Conferences and Seminars, the allocation for the Engineering Student Activities Funds has slightly decreased from previous years, but still remains large (15%).
- 5. Due to the lack of demand for competitions, the allocation for Conferences and Competitions is significantly decreased from previous years.

### **Appendix I: ESS Policy**

### **B.2.4. Distribution of Faculty Association Membership Fee**

### Relevant section of proposals to Students' Council regarding FAMF:

#### Scope:

The Engineering Faculty Association Membership Fee is a \$10.00 per term fee assigned to full-time students enrolled in the Faculty of Engineering.

#### Financial Oversight:

The Engineering Students' Society will require financial statements from the recipients who are not the ESS or ESAF indicating the anticipated expenditures to be made with the allocated funds. The Faculty Association Membership Fee funds received from the Registrar will be held separately from the remainder of the ESS' funds, under policies established by the Board of Directors and approved by a General Meeting.

The ESS will also require annual reports indicating how funds received from the fee have been spent from each of the recipients (excluding the ESS and ESAF) by March 31 of each year, and compile a report to the Students' Council as required by Bylaw 8200. The ESS will fully comply with any other legislation adopted by Students' Council with respect to financial oversight. The ESS will also open its books to Students' Council or delegated bodies for inspection under reasonable terms of access with respect to the fee.

The Board of Directors of the Engineering Students' Society is delegated the authority to require from each of the recipients that they provide to the Board a satisfactory accounting of their spending of fee money, and may withhold allocated funds if such an accounting is not provided. A General Meeting may overturn, uphold, or vary the decision of the Board of Directors. The Audit Committee of the Students' Union will be advised of actions taken by the Board of Directors and General Meetings.

### Policy:

- 1. Any changes to the distribution of FAMF must be made at a General Meeting, and will be reflected in the subsequent allocation of funds.
- 2. The current distribution of FAMF is as follows:
  - a. \$1.40 to the Engineering discipline clubs
  - b. \$1.90 to the Engineering Student Groups Fund
  - c. \$1.90 to the Engineering Student Activities Fund
  - d. \$0.50 to the Engineering Public Good Fund
  - e. \$1.50 to cover sending students to engineering conferences and competitions
  - f. \$0.75 to cover the printing costs of the Engineers' Handbook
  - g. \$0.15 to cover the costs of printing The Bridge
  - h. \$0.30 to cover health and wellness services
  - i. \$0.10 to the intramural sports fund



- j. \$0.20 to cover the costs of the Engineering Carnival
- k. \$1.00 to cover the costs of Geer Week
- I. \$0.30 to cover the costs of Spring Formal
- 3. Distribution of any funds allocated by a General Meeting to the Society for specific purposes shall be immediately dispersed upon receipt of the funds from the Students' Union.
- 4. Distribution of any funds allocated by a General Meeting to discipline clubs recognized by the ESS will be conducted as follows:
  - a. Upon receipt of the funds in the FAMF account, the Society will determine the allocations to the Clubs in adherence with the relevant policies, and submit such allocations to the Board of Directors for information.
  - b. Clubs must document how FAMF funds will be spent, and submit this information to the Society before receiving their allocation. The submission should contain:
    - i. detailed receipts for items spent in accordance with submitted proposals, if possible.
    - ii. a summary of how students have benefited from the FAMF funding.
  - c. Recipients who are not the Society that fail to submit the information outlined above, may have additional allocated funding withheld, at the discretion of the Board of Directors.
- 5. Members who have paid into FAMF will have the opportunity to have their contribution refunded if they are philosophically opposed or otherwise unable to contribute to the fund.
  - a. The deadline for requesting a refund shall be determined by the Vice-President (Finance), but shall occur at least once per term.
  - b. The opportunity to refund a FAMF contribution, and the date of the deadline to request this refund, must be well advertised to members through several media formats at least two weeks before the deadline.
  - c. The Society will, upon verification of the members' payment of the FAMF, refund this contribution by whatever means available no later than one month after the Society has received these funds.

### C.2.2. The Engineering Students' Activities Fund

#### Preamble:

The purpose of the Engineering Students' Activities Fund (ESAF) isto help engineering students attend seminars, conferences or sessions related to their engineering education.



### Policy:

- 1. The The Vice-President (Finance), President, and another Senior Executive shall have signing authority. All transactions require two of the aforementioned as signers.
- 2. ESAF proposals must be made by a full time undergraduate engineering student.
  - a. Each student may only access the fund once per academic year.
  - b. If a submission is rejected, a second proposal (for the same or a different activity), may be put forward.
  - c. Members representing engineering student groups must apply on an individual basis. Engineering student groups applying for ESAF risk being ineligible for ESGF funding as stated in policy C.2.4.1.b.
- 3. The proposal must be submitted before the activity takes place. Activities which take place between the submission date and prior to the decision of the committee are valid for consideration.
- 4. Any proposal deemed incomplete by the UFC shall be automatically rejected
- 5. The following expenses are approved for reimbursement up to \$800 for events within Canada, and up to \$1000 for events outside of Canada:
  - a. 100% of delegate fees
    - i. If accommodation is included in the delegate fee, it may still be covered 100%
  - b. Travel expenses up to 50%
  - c. Accommodation up to 50%
- 6. The UFC shall review the proposals as follows:
  - a. Each committee member shall receive and review a copy of the proposals.
  - b. The proposals will be evaluated according to (but not necessarily in the order of):
    - i. Student impact
    - ii. Economic sensibility
    - iii. Willingness to share the knowledge learned during the activity with students
    - iv. Other criteria at the discretion of the UFC
- 7. Awarded ESAF monies will not be distributed until after the activity has taken place. The following criteria must be met within 28 days of completion of the activity:
  - a. Completion of the ESAF post-conference form included in the application package
  - b. A blog post for the ESAF Blog
    - i. Can include text, images, video links, or other media at the discretion of the Director of Publications.
  - c. Completion of the other ways in which the recipient plans to share their ESAF experience as outlined in their proposal.
    - i. If these actions fall outside the above stated 28 days, reasonable action to complete them (scheduling, greater activity detail) should be provided in lieu.
  - d. Monies will only be reimbursed to the applicant whose name appears on the application form.

### C.2.3. The Engineering Student Groups Fund

### Preamble:

Non-discipline club engineering student groups contribute to student life in the Faculty of Engineering and are worthy of financial support through the Faculty Association Membership Fee. Accordingly, the Engineering Student Groups Fund provides financial support to assist these groups.

### Policy:

- 1. Qualifications to receive grant:
  - a. The student group must be registered with the Students' Union and be affiliated with the Faculty of Engineering.
  - b. The student group must not receive funds via the Engineering Students' Activities Fund Committee.
- 2. All grants will be judged on the merit of the project, including the following criteria:
  - a. how the funds will contribute to the success of the student group's event or function;
  - b. how the student group, engineering students, and the Engineering Students' Society will benefit from the funding;
  - c. how the money will improve the operations of the student group; and
  - d. financial need.
- 3. Applicant organizations are required to provide:
  - a. a complete annual budget for the current year
  - b. contact information for a representative of the student group;
  - c. a detailed budget for the specific request, including description and receipts (if applicable), and
  - d. a description of current fundraising activities including details of all funding currently received with respect to the request. All donations including labour and/or parts must be included in revenue.
- 4. Any proposal deemed incomplete by the UFC shall be automatically rejected
- 5. Documentation of revenues and expenses must be submitted within ninety (90) days of holding or attending an event, or at the time of the granting if it is for a past event. Failure to do so will result in a grant being converted into a loan which will be immediately repayable to the Engineering Students' Society.
- 6. A member of the Undergraduate Funding Committee that is a member of a group which has submitted a proposal or who has a conflict of interest concerning a proposal shall, at the meeting where that group's proposal is being considered, inform the Committee of that fact.
- 7. The committee shall evaluate and approve proposals as follows:
  - a. The committee shall determine which proposals are considered acceptable for voting; and if the sum of grants deemed acceptable for voting does not exceed the total available for granting, then the grants shall be awarded.
  - b. In the event that the sum of grants deemed acceptable for voting exceeds the sum available for granting the following procedures will be followed:



- i. Each committee member shall rank each proposal (1. being the first choice, 2. being the second choice, etc.) until all proposals have been ranked; and
- ii. After each committee member has ranked their choices, points shall be totaled and funds shall be awarded starting from the least total points and continuing until either the funds available for the current granting session are exhausted or no further proposals require funding.
- 8. Policy surrounding the meetings and composition of the Undergraduate Funding Committee are laid out in section B.1.3

### C.2.4. Engineering Public Good Fund

#### Preamble:

Student life in the Faculty of Engineering is driven by the entire undergraduate engineering population, and any student who believes that they can better improve the day to day experience if their degree should have a process by which to realize their vision. The Engineering Public Good Fund (EPGF) is purposed to help improve the quality of life of engineering students.

### Policy:

- 1. The allocation of the Engineering Public Good Fund shall be determined by the Engineering Undergraduate Funding Committee.
- 2. Qualifications to receive the grant
  - a. The proposal must be submitted by a full member of the Engineering Students' Society.
  - b. The proposal may not receive any funding from other sources within the Society
- 3. All grants shall be judged on the merit of the project, including the following criteria:
  - a. How the project will contribute to the improvement of the quality of life of the engineering student body;
  - b. Duration of the project;
  - c. How the project will be maintained throughout the first (1) year of operation and, if applicable, how the project will be transitioned into further years of operation;
  - d. Any consultations with other third parties outside of the Engineering Students' Society.
- 4. Applicant groups are required to provide
  - a. Contact information for a representative of the applicant group;
  - b. A detailed budget for the specific request, including descriptions and items (if applicable);
  - c. A description of other funding activities pertaining to the project. All donations including labour and/or parts must be included.



- 5. A member of the Engineering Undergraduate Funding Committee that is a member of the applicant group which has submitted a proposal or who has a conflict of interest concerning a proposal shall, at the meeting where that group's proposal is being considered, inform the Committee of that fact.
- 6. The committee shall evaluate and approve proposals as follows:
  - a. The committee shall determine which proposals are considered acceptable for voting; and if the sum of the grants deemed acceptable for voting does not exceed the total amount available for granting, then the grants shall be awarded;
  - b. In the event that the sums of grants deemed acceptable for voting exceed the sum available for granting, the following procedures will be followed:
    - i. Each Committee member shall rank each proposal (1. Being the first choice, 2. Being the second choice, etc) until all proposals have been ranked; and
    - ii. After each committee member has ranked their choices, points shall be totalled and funds shall be awarded starting from the greatest total points and continuing until either the funds available for the current granting session are exhausted or no further proposals require funding.
- 7. Once a proposal is accepted, the applicant group must meet the following requirements:
  - a. A monthly meeting with two (2) or more members of the Senior Executive for the duration of the approved proposal, unless otherwise requested upon the discretion of the UFC;
  - b. Monthly spending reports until the funded amount is completely utilized;
  - c. At the end of the duration of the proposal report must be presented to the Undergraduate Funding Committee detailing the following:
    - i. Total spending
    - ii. Usage or engagement numbers for the project
    - iii. Reception of the student body to the project
    - iv. Feedback collected from the student body about the project
  - d. For services resulting from the EPGF,
    - i. Any and all services shall include the name of the Society in its title;
    - ii. The details of the stewardship of the service must be included;
    - iii. A timeline of the service, no greater than one (1) year must be defined as the scope of the funding (maintenance cost would result in a re-application).
  - e. For Events resulting from the EPGF,
    - i. Any and all events shall include the name of the Society in its title;
    - ii. Events shall not be eligible for a second EPGF application in the year following its Funding Year without the consultation of the Board of Directors.
- 8. Failure to meet the requirements of funding shall result in the grant being converted into a loan which will be immediately repayable to the Society and future proposals from the applicant group shall be denied for the next academic year.
- 9. A report for each approved project shall be presented to the Board of Directors once per academic term by the chair of the UFC.

## **Budget Principles 2021-22**

This document is intended to serve as an outline of the fiscal priorities of the University of Alberta Students' Union for the fiscal year beginning May 1st, 2021, and ending April 30th, 2022. This document is legislated under Students' Council Standing Orders and is mandated as a responsibility of the Vice-President (Operations and Finance) under Bylaw 1100.

#### Preamble

The Students' Union is guided by our Strategic Plan. Our mission is to serve, represent, and engage students.

We offer services and businesses that provide for the needs of students.

We organize events and programs that build community on campus.

We advocate for student interests to the University, government, and the greater community. We provide and create space for students to relax, study, and socialize.

## Our guiding values are:

- Do what's right, not what's easy
- Inspire change for the world
- Act with unbridled compassion
- Always keep moving
- Learn from the past to improve tomorrow

# Our critical success factors and goals are:

## Empowering our students

- Inform, expand, and support students' rights.
- Prioritize equity, diversity, and inclusivity and the removal of barriers in order to ensure that student leadership reflects the student body.
- Support and advocate for the adoption of more versatile, effective, and fair discipline and dispute mechanisms.

# Fiscal Considerations

Budget principles shall outline the basic direction for the creation of the budget. The following adjustments lie outside of budget principles and, while they should be considered in the submission, are at the sole discretion of Students' Council and/or any other legislative body outlined in Bylaw:

- Alberta Consumer Price Index (ACPI) calculations for 2021-22
- Total membership revenue based on a blend of enrolment estimates and historical enrolment trends put forth by the University of Alberta in 2021
- Changes to the Post-Secondary Learning Act by the Government of Alberta
- Students' Union Membership Fee increases (beyond inflation) and decreases
- Students' Union Dedicated Fee increases (beyond inflation), decreases, creation, and/or elimination

#### **Principles**

- In the event that a section of this document conflicts with any other section, the Finance Committee shall identify such a conflict and propose any necessary changes in the presentation of the final budget.
- 2. Total operating and capital expenditures will not exceed the amount of total operating and fee revenues. The only exception to this would be Council approval on a budget that includes multi-year projections to resolve any deficits. For the 2021-22 fiscal year only, a deficit may be permitted due to the effects of the COVID pandemic, but a plan for returning to balanced budgets the following year must be provided. [Edited]
- 3. Capital budgeting shall be apportioned at the discretion of the Financial Controller and Vice President (Operations and Finance) after the operating budget has been created. Using the set amount of capital funds allocated, decisions for use of capital funds shall be made by the Core Manager responsible for each unit.



- 4. Growth in a department shall be offset by a variety of strengthened revenue streams in that department, where possible.
- 5. All departments must work within the mandate of the Students' Union; activities or operations deemed to be beyond its scope shall be eliminated. The 2019-23 Strategic Plan shall be used as a guide to assess the relevance and value prior to such decisions.
- 6. External entities such as dedicated fee units and operating grants shall be managed as per existing Students' Union Bylaws and applicable contracts.
- 7. Unless otherwise noted, operating and fixed costs increase at a rate relative to the previous fiscal year no higher than inflation for the province of Alberta; the activity of the Students' Union will continue in a manner consistent with the precedent set in previous fiscal years.
- 8. The Students' Union shall implement all necessary financial restraints and audits as required by the Post Secondary Learning Act and its own Bylaws and Standing Orders.
- 9. Unionized staff costs shall change as specified in the CUPE (Canadian Union of Public Employees) Local 1368 collective agreement of 2019-22. Out-of-scope staff are entitled to a Cost of Living Increase and a merit increase in accordance with their respective employment agreements and appraisal outcomes.
- 10. Operating and dedicated fees shall increase in accordance with the Students' Union Bylaw 3000, as set out in the 1992 referendum approving increases based on the Alberta Consumer Price Index (ACPI). Based on estimates, ACPI for 2021-22 will be approximately 1.3%. [Edited]
- 11. Funds will be allocated to develop non-fee reliant revenue sources and fundraising capabilities. [Edited]
- 12. Resources shall be made available for recurring projects of the Executive Committee, provided they can show the need for such resources and consistency of such projects.
- 13. Resources will be made available for the Executive Committee to build positive relationships with important stakeholders. Examples include Faculty Associations, Residence Associations, Aboriginal Student Council, International Students' Association, and members of the University of Alberta Board of Governors, General Faculties Council, and Senate. [Edited]
- 14. Resources shall be made available to promote and enhance visibility and constituency engagement for members of Students' Council, as well as to support Students' Council in its efforts to consult on decisions as deemed necessary.



- 15. The Students' Union shall allocate resources to provide sufficient support to student governance objectives.
- 16. The Students' Union business units shall strive to avoid budget deficits prior to cost apportionment allocations. All reasonable attempts to maximize the profitability of these business units, consistent with the mandate of the Students' Union as a service provider, shall be made.
- 17. The Students' Union shall allocate resources toward branding and engagement improvements.
- 18. Resources shall be made available for the sponsorship of events related to Students' Union activities that do not have a pre-existing Students' Union funding source.
- 19. The Students' Union shall continue to allocate resources toward enhancing the content on digital platforms.
- 20. The Students' Union should continue to invest in its student and professional staff through professional development options and enhanced training.
- 21. The Students' Union will continue to invest in taking steps towards reconciliation through continued allocation of funds for work on and completion of the 2019 Aboriginal Relations and Reconciliation recommendations. [Edited]
- 22. Resources will be allocated to support the Students' Union's efforts to make its operations, building, and services more environmentally sustainable.

## Removed from 2020-21

- 18. Where possible, all entertainment units shall plan to recover all costs. Admission sales, sponsorship, and donations are acceptable sources of revenue.
- 19. The Students' Union shall make resources available towards planning for the long-term maintenance and management of SUB.
