**2017-05/7a**    Bill #2 - Joke Candidates - *First Reading*

**CHRISTENSEN/FARRIS MOVE** to approve the first reading of Bill #2 - Joke Candidates, on the recommendation of Bylaw Committee.

**Points of Debate:**

*Point 1* could unfairly target transgender candidates or prevent students from running as a joke candidate under their given name.

**BANISTER/FLAMAN MOVE** to AMEND *Point 1* as follows:

A joke candidate is defined as any candidate(s) who self-identifies as a joke candidate in a written capacity on their nomination form.

**Points of Debate:**

- This amendment leaves it entirely up to the candidate to self-identify which could allow someone to legitimately run for a position under a joke name.
- There should be a way for obvious joke candidates to be classified as such even if they don't self-identify as such.
- It's not the place of Students' Council or the Elections staff to dictate how someone wants their name to appear on the ballot.
- If there's a lot of debate on this amendment, it should be moved back to committee where a more robust discussion can take place.
- Amending this point now drastically changes the scope of the original legislation brought forward so it should be returned to committee.

**FLAMAN/HOWIE MOVE** to refer the item back to the Bylaw Committee.
