2016-24/2a Interim Vitreo Group Feasibility Report - Presented by Mick Mulloy, Senior Associate, Vitreo Group and Scott Decksheimer, Partner, Vitreo Group. - Sponsored by VP Paches and Seconded by Councillor Flaman.

Earlier this year, Students' Council approved the commissioning of a feasibility study on fundraising for the Myer Horowitz Theatre Renovation Project. Vitreo Group was selected to conduct this study, and is making this presentation to provide an interim report on their findings thus far.

Councillor Flaman to Mr. Decksheimer: you mentioned most people were in favor but not everyone. What were the concerns?

Mr. Decksheimer's response: Its about the persona. What's the venue going to be like/? Will it be multipurpose? Will it be money-making? Should SU invest in this or not? Its about whether it's the right idea, not about whether it's a bad idea.

Councillor Monda to Mr. Mulloy: What other groups of people have you reached out to as potential donors?

Mr. Mulloy's Response: There were 4 groups that we looked at: people that have interest in arts; SU executives from the past; people from the general community; people connected to times of Myer Horowitz

PRESENTATION EXTENDED BY 5 MINUTES

Councillor Ndatirwa to Mr. Mulloy: Who are the "right people" that you talked about earlier?

Response by Mr. Mulloy: It depends on the person that we are talking to. The right person is usually a volunteer, not someone who we might pay.

VP Ghossein to Mr. Decksheimer: How much are students paying at the end of the day for this project? Are you putting a number out there and gauging their willingness to get there?

Mr. Decksheimer' Response to VP Ghossein: We are using a gift table. At the top is about a million dollars. We are looking to get some indication of whether people are looking to donate.

VP Paches to Mr. Mulloy: I'm curious if you gave any other university campaigns? And were they a success?

Mr. Mulloy to VP Paches: There's an issue of confidentiality, so I'll just be general about it. There is a library and hospice project that we looked into. Our job is to give really good honest advice which is useful.
